Following a brief discussion, Supervisor Marc Sharpe offered and Supervisor W.T. "Bill" Banks seconded a motion to enter into "Executive Session" to discuss prospective litigation as provided by law. The vote on said matter was as follows:

President Richardson then reopened the meeting and informed the public of the reason for the Executive Session being taken.

The Board of Supervisors no took action in the Executive Session and upon a unanimous vote of the Board members present the President declare the Board of Supervisors to again be in open session to consider all county business.

There being no further business to come before the meeting of the Board of Supervisors of Madison County, Mississippi, upon motion duly made by Supervisor Marc Sharpe and seconded by Supervisor W.T. "Bill" Banks and approved by the unanimous vote of those present, the meeting of the Board of Supervisors was adjourned.
