

**Quick Notes: The Madison County Board of Supervisors Meeting, June 15, 2020**

- The Madison County Board of Supervisors (the Board) acknowledged a letter from NCL Waste, LLC attorney to be removed from the June 15, 2020, Board of Supervisors meeting agenda to allow NCL additional time to meet with the Board Attorney and other interested parties to more thoroughly evaluate the options and alternatives available to the parties prior to any action by the Board.
- The Madison County Fire Coordinator announced last night that the Mississippi State Rating Bureau decreased the South Madison Fire District's rating from 6<sup>th</sup> class to 5<sup>th</sup> class. This new rating may allow taxpayers, within the district, to receive a decrease in individual property fire insurance rates. Please contact your homeowner's insurance company to see if you qualify.
