 The Madison County Board of Supervisors, (the Board), heard from Butler Snow's Tommie Cardin regarding redistricting the supervisor district lines due to the most recent census. Cardin outlined the proposed meeting –

-Purpose: Transparency will be enhanced by providing for citizen input about

the redistricting process.

-Format: Butler Snow and the Central Mississippi Planning and

Development District will lead the hearing that will offer maps, the results of the census, legal issues, and a draft of the new map for the district lines. Time for statements and questions from attendees

will be provided.

The public hearing is scheduled for January 25, 2022, at 6:00 p.m. in the Board room in the Administrative Building in Canton.

- The Board voted to renew lobbying contracts for Butler Snow and the Clearwater Group.
- The Board approved granting tax exempt status to Mount Zion Missionary Baptist Church.
- The Board approved granting tax exempt status to Goodwill Industries of Mississippi.
- The Board approved the 2021-2022 budget for the Madison County Megasite Alliance fire protection of \$80,550.
- The Board acknowledged a notification letter regarding a better fire protection classification, Class 8, for the Southwest Madison County Fire Protection District. Please contact your insurance company to see if you qualify for a decrease in premiums.
- The Board approved an agreement with Entergy for relocation of distribution facilities on Bozeman Road that conflict with roadway improvements. The cost for this work is \$672,626.28.
- The Board approved GSM, LLC's final plat of Ashby Ridge, Phase 2. The development is approximately 19.4 acres with thirty-five lots at roughly ¼ acre each.
- The Board approved the reduction of the speed limit on Cedar Hill Road from Highway 22 to MS 463 from 45 mph to 35 mph, for safety.

- The Board acknowledged an updated Emergency Action Plan for Sulphur Springs Park Lake.
- The Board approved the preliminary plat for Deerfield Clubhouse Estates.
- The Board approved the preliminary plat for Glendale Farms.
- The Board approved the preliminary plat for Bellemeade of Caroline.
- The Board approved the preliminary plat for Magnolia Pointe part two.
- In observance of Christmas, County offices will be closed December 23-December 27. Garbage collection will run on a normal schedule.
- In observance of New Year's, County offices will be closed December 31. Garbage collection will run on a normal schedule.
- The Board approved a grant application for Emergency Management Performance.
- The Board voted to spend approximately \$600 for a topography survey at Sulphur Springs.
- The Board voted to acknowledge the Circuit Clerk Employee Handbook.
