

**The Madison County Board of Supervisors Meeting: February 21, 2023: Quick Notes**

- The Madison County Board of Supervisors, the Board, were updated by Comcast regarding the broadband project in Northern Madison County. The project will install infrastructure for approximately 3,175 homes to access high-speed internet. Comcast agreed to apply for a grant through the United States Department of Agriculture while also pursuing other grant opportunities at the both the state and federal levels. The County allocated \$10mm of their American Rescue Plan Act (ARPA) funds for this \$25mm project but grant awards may allow the county to forego spending any county funds on the project.

- The Board accepted the low bidder, Hemphill Construction Company, Inc., to construct Reunion Phase 3 (two lane road, with bike lanes, from Parkway East to Highway 51) for \$22,738,264. The project will begin in approximately four months and is expected to take 24 months to complete.
- The Board approved a request by the City of Madison to purchase communications equipment for approximately \$78,000.
- The Board approved an Interlocal Agreement between Madison County and the City of Gluckstadt for improvements to Bozeman Road within their municipal limits.
- The Board approved an Interlocal Agreement between Madison County and Town of Flora for the overlay of Pocahontas Road partially using Jackson Metropolitan Planning Organization (MPO) funding. This Interlocal Agreement formally approves the County's commitment of \$154,897.

- The Board approved submitting a permit to perform work on MDOT right-of-way at the intersection of Bozeman Road at MS Highway 463.
- The Board approved advertising for the construction of the Yandell Road Bridge Project.
