### REGULAR MEETING OF DECEMBER 12, 2003

Recessed from regular meeting conducted on December 5, 2003

BE IT REMEMBERED that the regular meeting of the Board of Supervisors of Madison County, Mississippi was duly convened, held and conducted on the 12th day of December, 2003, at the Madison County Chancery/Administrative Building in Canton, Mississippi, as follows, towit:

The President of the Board, David H. Richardson, presided and called the meeting to order. The following members were present that day:

The President announced that the members of the Board present constituted a quorum and declared the meeting duly convened. Supervisor W.T. "Bill" Banks opened the meeting with a prayer and Supervisor Paul Griffin led the Pledge of Allegiance to the Flag of the United States of America.

### In the Matter of Conducting a Public Hearing on the Amendment to the Planned Unit Development at Lake Caroline

WHEREAS, the Board of Supervisors had previously advertised its intent to conduct a public hearing and had authorized the publication of public notice in the *Madison County Herald*, a newspaper of general circulation within Madison County, and directed that the Clerk of this Board publish notice at least twice in said paper, the first of which such notice was published at least fifteen (15) days prior to the date of this public hearing; and

WHEREAS, the Board of Supervisors also directed that signs be placed along said property giving additional notice to residents of this area of a potential rezoning; and

WHEREAS, the date and hour as advertised did arrive and the Board of Supervisors opened the public hearing to consider the request of A&F Properties, LLC to approve a residential development within the Planned Unit Development at Lake Caroline; and

WHEREAS, the Board of Supervisors considered testimony from Todd Burwell, an Attorney for the Petitioner, along with additional testimony from Craig Foshee, the owner of A&F Properties, LLC, as well as additional testimony from Tom Bobbitt, landscape architect, and Andrew L. Smith, a certified Planner; and

WHEREAS, A&F Properties, LLC, also submitted exhibits in the form of a booklet which is found in the miscellaneous file to these minutes; and

WHEREAS, numerous parties appeared objecting to the request and the Board of Supervisors heard testimony from Tom Cook, attorney for Lake Caroline, Inc., who submitted certain arguments and documentation and exhibits which are made a part of the record hereof and are found in the miscellaneous file to these minutes and further requested the Board of Supervisors to review its own Zoning Ordinance and Minutes and other regulations in reviewing this matter to reach a decision; and

WHEREAS, the Board of Supervisors also heard testimony and received evidence from Mr. Steve Smith, an attorney for the Lake Caroline Homeowners Association, and that copies of the exhibits and other documentation submitted by Mr. Smith are found in the miscellaneous file to these minutes.

Following additional discussion of this matter, Supervisor Karl M. Banks moved and Supervisor Paul Griffin seconded a motion to table the request submitted by A&F Properties, LLC due to said request being determined to have been premature by virtue of certain contractual agreements made by A&F Properties, LLC prohibiting said entity from conducting any other operation on the subject property other than a golf course until the year 2006 and to further request that prior to consideration of this issue in the future that adequate notice in hearing be given to the general public and all parties represented before the Board at this public hearing. # In the Matter of the Consideration of the Purchase of Right-of-Way from J.D. Rankin on Yandell Road

### In the Matter of the Approval of Offering Compensation for Settlement of Claims on Yandell Road

WHEREAS, Mr. Woody Sample with Sample & Associates appeared before the Board of Supervisors and informed the Board of certain title problems associated with the Yandell Road improvement project whereby certain landowners may have claims of adverse possession along said project; and

WHEREAS, Mr. Sample recommended that the Board of Supervisors settle these claims for right-of-way for \$375.00 per parcel along said project to avoid any litigation or other disputes with landowners adjoining said roadway by virtue of any adverse possession claims.

In the Matter of the Adoption of an Ordinance Re-zoning Property for and on Behalf of Community First Development, Inc.

# ORDINANCE BY THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI, AMENDING THE MADISON COUNTY ZONING ORDINANCE

WHEREAS, Community First Development, Inc., did file an Application to rezone certain property from its present R-1 Residential Use District Classification to R-2 Residential Use District Classification with a PUD Overlay; and

WHEREAS, by Resolution properly adopted by the Board of Supervisors on the 10<sup>th</sup> day of October, 2003, a hearing was set for the 21<sup>st</sup> day of November, 2003, at 10:00 o'clock a.m., and the Clerk did cause Notice of said hearing to be published in the Madison County Herald, a newspaper published and of general circulation in Madison County, Mississippi, in the manner and for the time required by law; and

WHEREAS, the hour of 10:00 o'clock a.m. on the 21<sup>st</sup> day of November, 2003, did arrive and the Board of Supervisors conducted a public hearing on said matters and after closing said public hearing tabled said matter; and

WHEREAS, the Board of Supervisors determined it would consider this matter; and

WHEREAS, the matter was presented to the Board of Supervisors and after discussion thereof Supervisor W.T. "Bill" Banks offered the following Ordinance and moved that it be adopted, to wit:

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI, AS FOLLOWS, TO WIT:

1. That the following described tract of real property be, and the same is hereby, rezoned from its present R-1 Residential Use District Classification to R-2 Residential Use District Classification with a PUD Overlay, to wit:

A parcel of land lying and situated in the NE ¼ of Section 27, T8N, R2E, Madison County, MS, being more particularly described as follows:

Commence at an iron pin representing the SE corner of the NE ¼ of Section 27 and run thence North 00 degrees 04 minutes 41 seconds West along the West right-of-way of Clarkdell Road for a distance of 287.05 feet to an iron pin at the intersection of the west right-of-way of Clarkdell Road and the east right-of-way of Clarkdell Extension which is the point of beginning of the parcel herein described. From the Point of Beginning run thence northwesterly along the east right-of-way of Clarkdell Extension and along the arc of a curve to the left having a radius of 555.29 feet, a delta angle of 36 degrees 48 minutes 03 seconds a chord bearing of North 44 degrees 28 minutes 07 seconds West, a: chord distance of 350.56 feet and an arc length of 356.66 feet for a distance of 356.66 feet to an iron pin; thence run North 63 degrees 02 minutes 06 seconds West along said right-of-way for a distance of 331.58 feet to an iron pin; thence run northwesterly along said right-of-way and along the arc of a curve to the right having a radius of 470.00 feet, a delta angle of 41 degrees 07 minutes 28 seconds a chord bearing of North 42 degrees 28 minutes 23 seconds West a chord distance of 330.15 feet and an arc length of 337.34 feet for a distance of 337.34 feet to an iron pin; thence run North 21 degrees 54 minutes 40 seconds West along said right-of-way for a distance of 37.57 feet to an iron pin; thence run North 68 degrees 05 minutes 20 seconds East for a distance of 10.00 feet to a point; thence run North 21 degrees 54 minutes 40 seconds West for a distance of 50.00 feet to a point; thence urn South 68 degrees 06 minutes 20 seconds West for a distance of 10.00 feet to an iron pin; thence North 21 degrees 54 minutes 40 seconds West along said rightof-way for a distance of 984.93 feet to an iron pin; thence run North 68 degrees

30 minutes 03 seconds East along a line parallel to the southerly right-of-way of Yandell Road (circa October, 2001) for a distance of 849.30 feet to an iron pin; thence run South 88 degrees 21 minutes 34 seconds East for a distance of 373.32 feet to an iron pin on the westerly right-of-way of Clarkdell Road (circa October, 2001); thence run South 00 degrees 04 minutes 41 seconds East along said westerly right-of-way for a distance of 1938.96 feet to the Point of Beginning. This parcel contains 33.10 acres, more or less.

That this re-zoning is contingent on the owner revising the covenants submitted with this project to reflect 1800 square foot minimum heated and cooled area restrictions and providing that said covenants may not be amended without the consent of the Board of Supervisors. That the Madison County Zoning Ordinance be and the Zoning District Map and Land Use Plan be and the same are hereby amended so as to reflect the foregoing change in the zoning of the above described real property.

ORDAINED, ADOPTED AND APPROVED by the Board of Supervisors of Madison County, Mississippi, at a meeting thereof held on the 12<sup>th</sup> day of December, 2003.

WHEREAS, Mr. Sellers further informed the Board that the building permit was issued on property located within the City of Canton and not within the jurisdiction of Madison County and that the City of Canton had agreed to honor the partial inspections by Madison County made on the premises and therefore the County should refund the amount of \$520.00 to Waren Building Company which was collected in error and for inspections not yet made by Madison County personnel.
