### In the Matter of the Approval of a Resolution Declaring its Intention To Raise and Covenanting to Continue its Levy of Ad Valorem Taxes for Capital Improvements of the Holmes Community College District

There then came on for consideration the matter of the ad valorem tax levy of Madison County, Mississippi, for capital improvements for Holmes Community College District. Following a discussion of the matter, Supervisor W.T. "Bill" Banks moved the adoption of the following resolution:

A RESOLUTION OF THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI, DECLARING ITS INTENTION TO RAISE AND COVENANTING TO CONTINUE ITS LEVY OF AD VALOREM TAXES FOR CAPITAL IMPROVEMENTS OF THE HOLMES COMMUNITY COLLEGE DISTRICT.

**WHEREAS**, the Board of Supervisors (the "Board") of Madison County, Mississippi (the "County") hereby finds, determines, adjudicates and declares as follows:

- 1. The County, together with other counties, has organized the Holmes Community College District (the "District") pursuant to the authority of Chapter 29, Title 37, Mississippi Code of 1972, as amended, which District is under the governance of a Board of Trustees.
- 2. Under the authority of Section 37-29-141, Mississippi Code of 1972, as amended, the County is authorized to levy up to three (3) mills for general support of the District and up to three (3) mills for capital improvements for the District. The County is currently levying .48 mills for capital improvements of the District pursuant to said Section.
- 3. Commencing in 2003, the District proposes to use funding from the District and the County to construct additional infrastructure at the Madison Campus in order to substantially increase the number of students served by the District at the Madison Campus.
- 4. The County's funding for said infrastructure is to come from a part of the avails of the aforesaid .48 mills now levied by the County for capital improvements for the District, plus an additional not to exceed 2.52 mills for said purpose, which together may be used for the repayment of bonds or notes of the District to be issued for a period of 22 years to pay for the construction of the new infrastructure.
- 5. It is appropriate and in the public interest for the Board to declare its intent and it is necessary and in the public interest for the Board to covenant, commencing with fiscal year 2004, pursuant to said Section 37-29-141, to increase its levy for the District not to exceed 2.52 mills for a total capital improvement levy for the District of not to exceed 3 mills.
- 6. It is appropriate and in the public interest for the Board to declare its intent and it is necessary and in the public interest for the Board to covenant for the benefit of the District and for any holders of any bonds or notes of the District to continue to levy not to exceed 3 mills for capital improvements of the District through the 2026 levy made for the fiscal year ending September 30, 2027.

### **NOW, THEREFORE, BE IT RESOLVED** by the Board as follows:

- **SECTION 1.** The Board hereby declares its intention and covenants for the benefit of the District commencing with fiscal year 2004 to increase its levy for capital improvements of the District pursuant to Sections 37-29-141, Mississippi Code of 1972, as amended, not to exceed 2.52 mills for a total capital improvement levy for the District of not to exceed 3 mills.
- **SECTION 2.** The Board hereby declares its intention and covenants for the benefit of the District and for any holders of any bonds or notes of the District to continue to levy not to exceed 2.52 mills for capital improvements of the District through the 2026 levy made for the fiscal year ending September 30, 2027.
- **SECTION 3.** All funds derived from such levies shall be paid out of the depository of the County for capital improvements of the District in the manner prescribed by law.

**SECTION 4.** In the event any section of this resolution shall be determined to be unenforceable or null and void the remainder of this resolution shall nevertheless remain in full force and effect.

Supervisor Karl M. Banks seconded the motion to adopt the foregoing resolution (a copy of which is found in the miscellaneous file to these minutes), and the question being put to a roll call vote, the result was as follows:
