WHEREAS the Board of Supervisors of Madison County, Mississippi, by virtue of its authority, has decided to lay out, repair, change, construct, reconstruct, pave and maintain a segment of N. Livingston Road located in Supervisor District No. 3 of Madison County, Mississippi, as a County public road, in conjunction with a State Aid Project and as is shown by the plans, maps and plats prepared by Engineering Associates, Inc., all of which are now on file in the offices of the Clerk of this Board, and which are made a part hereof by reference; and
