MINUTES OF THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI

REGULAR MEETING OF OCTOBER 10, 2003 Recessed from regular meeting conducted on October 6, 2003

BE IT REMEMBERED that the regular meeting of the Board of Supervisors of Madison County, Mississippi was duly convened, held and conducted on the 10th day of October, 2003, at the Madison County Chancery/Administrative Building in Canton, Mississippi, as follows, towit:

The President of the Board, David H. Richardson, presided and called the meeting to order. The following members were present that day:

The President announced that the members of the Board present constituted a quorum and declared the meeting duly convened. Supervisor W.T. "Bill" Banks opened the meeting with a prayer and Supervisor Paul Griffin led the Pledge of Allegiance to the Flag of the United States of America.

In the Matter of Conducting a Public Hearing Regarding the Proposed Amendment to the Madison County Solid Waste Plan

WHEREAS, the Board of Supervisors had previously advertised its intent to conduct a public hearing regarding an amendment to the Madison County Solid Waste Management Plan to include additional property for a Class I Rubbish Facility on property owned by ABC, LLC being located at 2353 North County Line Road, Ridgeland, Mississippi 39157 and being located in Sections 19 and 30, Township 7 North, Range 1 East, Madison County, Mississippi with said site to be operated by Madison South Rubbish Landfill, Inc.; and

WHEREAS, the Board of Supervisors had previously given notice of its intent to review this proposed revision to the Solid Waste Management Plan to all the adjoining counties and to the Department of Environmental Quality of the State of Mississippi as required by law; and

WHEREAS, the Board of Supervisors did further advertise its intent to conduct a public hearing on this matter by publishing notice in the *Madison County Herald*, a newspaper of general circulation in Madison County, Mississippi; and

WHEREAS, the date and hour as advertised did arrive and the Board of Supervisors did convene said matter and consider comments and other evidence regarding the inclusion of the above described property in the Solid Waste Management Plan for Madison County, Mississippi and that a copy of the proposed amended sections of the plan are found in the miscellaneous file to these minutes; and

WHEREAS, the Board did receive testimony from Mr. Jerry Mills, attorney for the petitioner, who presented pictures and other evidence of a public need for said facility due to illegal dumping in this area as well as the density of the population in Madison County; and

WHEREAS, the Board of Supervisors also received testimony from Mr. Dwayne Ballard for and on behalf of petitioner who testified as to the public need for this type of facility in the area and gave further evidence as to the type of precautions to be used in the operation of said facility.
