State Aid Project SAP-45(52) Madison County

ORDER OF MADISON COUNTY BOARD OF SUPERVISORS AWARDING CONTRACT AND ESTABLISHING PROJECT FUND FOR THE ABOVE NUMBERED PROJECT

WHEREAS, said Board has on the 26^{th} day of September, 2003, received and opened bids on said project, and

WHEREAS, We the Board of Supervisors of Madison County, Mississippi, having advertised for bids on the above numbered project and proofs of publication of said advertisement having been filed with the Clerk of the Board of Supervisors in the manner and form required by statute; and

WHEREAS, the lowest regular bid was submitted by Dickerson & Bowen, Inc. of Brookhaven, Mississippi in the amount of \$639,313.37.

NOW, THEREFORE, IT IS HEREBY ORDERED by this Board of Supervisors of Madison County that the contract be awarded to Dickerson & Bowen, Inc. subject to approval of the State Aid Engineer, and that the President of the Board be and he is hereby authorized to execute the contract with the Contractor after a satisfactory performance bond has been furnished.

IT IS FURTHER ORDERED that the project fund in the amount of \$671,300 (including 5% contingencies) and an additional amount, limited to 12% of contract construction cost, to cover engineering services of \$76,700, be established by transferring a total of \$748,000 State Aid Funds from Madison County's State Aid fund to a project fund and earmarked for this project. The State Aid Engineer is authorized to take such action as necessary to effectuate this transfer. In case of unexpected overruns in costs which would increase the cost of the project beyond the amount of the project fund established herein, the State Aid Engineer is further authorized to transfer additional funds, limited to 10% of the construction costs, to the project fund as are needed to pay such overruns in final construction costs.

IT IS FURTHER ORDERED that the President of the Board is hereby authorized to execute Supplemental Agreements to the original contract which do not increase the cost of the project in excess of the project funds authorized herein. It is also ordered that the State Aid Engineer be furnished a certified copy of this order, and that a copy of this Order is found in the miscellaneous file to these minutes.

In the Matter of Authorizing the Amendment to the Madison County Ordinance for Ambulance Service and to Further Amend the Agreement to Provide Advanced Life Support Ambulance Service with AMR Ambulance Service

WHEREAS, the Board of Supervisors did previously adopt an ordinance for ambulance service and that said Board does now desire to amend Section 2.08 of said ordinance to read as follows:

The EMS Lead Agency is the organization delegated the responsibility for coordinating all components and are aspects of the entire EMS system in the County, including but not limited to, Emergency Medical Service components of Homeland Security plans enacted by the County. It will have the ultimate responsibility of providing this care along or delegating part if this responsibility. It shall further be the responsibility of the EMS Lead Agency to constantly evaluate the response of all EMS support services in areas of appropriateness of prehospital care and medical control. The EMS Lead Agency shall also be authorized to develop and implement patient transportation and destination policies and guidelines. It shall sanction EMS continuing education activities, establish infection control standards for all prehospital EMS personnel, direct patient refusal procedures, and other EMS related activities. The EMS Lead Agency is authorized to enter into mutual aid agreements with other EMS, public safety and ancillary support agencies.

WHEREAS, the Board of Supervisors did further enter into an agreement to provide Advance Life Support Ambulance Service with AMR Ambulance Service and now desires to amend two sections to read as follows:

Section 2.2

Pursuant to Section 41-59-51, et. Seq., Mississippi Code of 1972, the County designates AMR as the EMS Lead Agency and EMS Authority of the Madison County EMS District. The County may elect to join another contiguous EMS District operated by the Lead EMS Agency for the purposes of regionalization of oversight and direction of the EMS system.

Pursuant to Section 41-59-55(b), the County appoints the highest ranking local operations officials of AMR as the Executive Manager of the EMS District. This Executive Manager shall have fully authority over the operation of the District

Section 2.1

<u>Subsidy</u>: The county will provide an annual subsidy to AMR in the amount of \$0.15 per capita based upon the most current federal census, or the minimum subsidy required by the Mississippi State Department of Health Division of Emergency Medical Services to participate in the Emergency Medical Services Operating Fund (E.M.S.O.F.) grant program. The subsidy shall be payable to AMR each year in October.
