## REGULAR MEETING OF AUGUST 24, 2001 recessed from regular meeting conducted on August 17, 2001

BE IT REMEMBERED that the regular meeting of the Board of Supervisors of Madison County, Mississippi was duly convened, held and conducted on the 24th day of August, 2001, at the Madison County Chancery/Administrative Building in Canton, Mississippi, as follows, towit:

The President of the Board, David H. Richardson, presided and called the meeting to order. The Clerk of the Board then called the roll with the following results:

In the Matter of Acknowledging New Rates Per County Employees' Health Insurance Plan

WHEREAS, Vangie Pickering with Fox-Everett, Inc., did appear before the Board of Supervisors and present information concerning the new rates for insurance and reinsurance for the County and did further review the existing benefits provided to County employees, and discussed certain options or possibilities for changes to said benefits.

WHEREAS, both the Tax Assessor and Tax Collector have investigated Mr. McPhail's claim and have determined that Mr. McPhail was assessed with an extra improvement which was not, in fact, on his property; and

WHEREAS, the Board of Supervisors desires to request that the Tax Collector refund to Mr. McPhail those sums due as a result of his overpayment of taxes which amount to \$17.07 for the year 1998, and \$208.47 for the year 1999.
