RESOLUTION PROPOSING THE ESTABLISHMENT OF THE MADISON COUNTY WASTEWATER AUTHORITY

WHEREAS, the Mississippi Legislature did pass House Bill 1640 during its 2001 Regular Session authorizing the Board of Supervisors of Madison County, Mississippi, to establish a Wastewater Authority to serve the Citizens of Madison County, Mississippi; and

WHEREAS, the Board of Supervisors of Madison County desires to establish said Wastewater Authority, as authorized by said Act.

NOW BE IT THEREFORE RESOLVED by the Board of Supervisors of Madison County, Mississippi that said Board proposes to establish a Wastewater Authority as allowed by House Bill 1640 (Regular Session 2001) and does expressly find as follows, to-wit:

- That the service or services to be supplied by the proposed Wastewater Authority are necessary and in the best interest of health and welfare of the Citizens of Madison County, Mississippi; and
- 2. That the proposed corporate name for the authority is the "Madison County Wastewater Authority"; and
- That the proposed boundaries of the authority, will include all of Madison County,
 Mississippi; and
- 4. That the estimate of the cost of the acquisition or construction of the facilities to be operated by the authority is \$149,000,000.00; however, said estimate shall not serve as a limitation upon the financing of the creation, operation, improving upon or extending of the Authority.

BE IT FURTHER RESOLVED that the Board of Supervisors does hereby set this matter for a public hearing at 10:00 a.m. on Friday, December 14, 2001 at the Board of Supervisor Meeting

Room, located in the Madison County Chancery Administrative Building at 146 West Center Street, Canton, Mississippi and does hereby order the Clerk of this Board to publish a notice of said hearing in the Madison County Herald, a newspaper having general circulation in Madison County, Mississippi, notifying the public that at said time and place the Board of Supervisors will conduct said public hearing upon the question of the public convenience and necessity of the incorporation and creation of the proposed Wastewater Authority.

Commence at the Point of Intersection of the East line of the aforesaid Northwest 1/4 of the Southwest 1/4 of Section 24 with the North right-of-way line of West Fulton Street (as now laid out and improved) and run thence South for a distance of 74.94 feet to a point on the North line of Lot 1, Block "A" of said Fair Ground Addition to the City of Canton; run thence South 78 degrees 27 minutes 52 seconds West along said North line of Block "A", Fair Ground Addition to the City of Canton for a distance of 120.28 feet to the Point of Intersection of the South right-of-way line of said West Fulton Street with the East right-of-way line of said Forth Avenue (undeveloped); leaving said North line of Block "A", Fair Ground Addition to the City of Canton and said South right-of-way line of West Fulton Street, run thence South 00 degrees 02 minutes 09 seconds East along said East right-of-way line of Forth Avenue (undeveloped) and along the West line of said Block "A", Fair Ground Addition to the City of Canton for a distance of 345.32 feet to a point on the North line of the Charles F. Riddell property as described in deed recorded in Deed Book 265 at Pages 170, 171 and 172, on file and of record in the aforesaid Chancery Clerk's office; said point being the POINT OF BEGINNING of the parcel of land herein described; from said POINT OF BEGINNING, continue thence South 00 degrees 02 minutes 09 seconds East along said East right-of-way line of Forth Avenue (undeveloped) and along said West line of Block "A", Fair Ground Addition to the City of Canton for a distance of 671.56 feet; leaving said East right-of-way line of Forth Avenue (undeveloped) and said West line of Block "A", Fair Ground Addition to the City of Canton, run thence South 89 degrees 57 minutes 51 seconds West for a distance of 40.00 feet to a point on the West right-of-way line of said Forth Avenue (undeveloped); said point also being on the East line of Block "B" of said Fair Ground Addition to the City of Canton; run thence North 00 degrees 02 minutes 09 seconds West along said West right-of-way line of Forth Avenue (undeveloped) and along said East line of Block "B", Fair Ground Addition to the City of Canton for a distance of 670.04 feet to a point on the aforesaid North line of the Charles F. Riddell property; leaving said West right-of-way line of Forth Avenue (undeveloped) and said East line of Block "B", Fair Ground Addition to the City of Canton, run thence North 87 Degrees 40 minutes 00 seconds East along said North line of the Charles F. Riddell property for a distance of 40.03 feet to the POINT OF BEGINNING, containing 26,833.9 square feet, more or less.

WHEREAS, Mr. Riddell, through his attorney, did state that said roadway does not provide primary access to any occupied properties, and that traffic on said road has, for a period of at least ten (10) consecutive years, been intermittent and of such low volume, and that no substantial public purpose is being served thereby, and that the Board of Supervisors has, for a period of at least the previous five (5) consecutive years, not maintained said section as a part of the county road system, and that the public interest nor convenience does not require the section to remain open to the public, and that it is in the public interest or convenience to close, vacate and abandon said roadway.

Griffin did second a motion to set a public hearing for December 21, 2001 at 10:00 a.m. on the question of the abandonment of the afore-described road and did further request the Clerk to publish notice of such hearing at least two (2) times, not less than two (2) weeks prior to the date of hearing, in a newspaper having a general circulation within said county. WHEREAS, Sheriff Toby Trowbridge did appear before the Board of Supervisors and request the Board to authorize him to apply for a grant for an on behalf of Madison County from the United States Government for 30 bullet-proof vests totaling \$17,307.60, and did further inform the Board that the grant required a 50% match or \$8,653.80 under the terms and conditions of said application.
