In the Matter of an Appearance Before the Board by Gerald Barber, Tax Assessor

WHEREAS, Mr. Gerald Barber, Tax Assessor of Madison County, did appear before the Board of Supervisors and express concerns regarding the adoption of his budget. No official action was taken by the Board regarding this matter.

In the Matter of a Request for Conditional Use of Property in an R-1 Residential District to allow the Placement of a Mobile Home

WHEREAS, Ms. Lawanda Stiff filed a petition with the Board of Supervisors of Madison County requesting a special exception to the zoning ordinance of Madison County and requested a conditional use of certain property located in Section 25, Township 8 North, Range 2 East, Madison County, Mississippi to allow the placement of a mobile home in an R-1 Residential District; and

WHEREAS, Ms. Stiff did state in her petition (copies of which are found in the Miscellaneous File to these Minutes) that she intended to convert said mobile home to a permanent dwelling unit and the Planning Commission recommended its approval.

districts, and the rates or levies which are required to produce the revenue necessary to meet the budget was made, fixed and heretofore be finally approved by this Board on the 14th day of September, 2001, as required by law; and it having been ascertained that the maintenance levies for the various school districts and the county-wide school maintenance levy and the Persimmon Burnt-Corn Water Management District and other taxing districts are supported by law, and it appearing that the tax rates or levies for the county and the several purposes, the road districts, and other taxing districts, the school districts are necessary in other to raise funds required to meet the expenses for the said fiscal year 2001-2002.

IT IS, THEREFORE, ORDERED AND ADJUDGED by the Board of Supervisors of Madison County, Mississippi, that the following ad valorem tax rates or levies be and the same are hereby imposed and levied for the fiscal year 2001-2002 upon the assessed value of all taxable districts, school districts, Persimmon Burnt-Corn Water Management District, and all other taxing districts in Madison County, Mississippi, as the property is now assessed and listed, or as may be hereafter assessed and listed as of January 1, 2001 (except property subject to State Tax only or those specific levies so provided for in Senate Bill 2671, 1980 Regular Session of the Mississippi Legislature), and except exempted assessed value of homes to the extent exempted by the Homestead Act of 1946, as amended, and Senate Bill 2566, as might be amended, the said rates expressed in mills or a decimal fraction of a mill, being levied and imposed upon each dollar of assessed valuation appearing upon the assessment rolls of said county for the following funds or purposes; and when the money is collected, it shall be credited to the respective funds as provided by law:

Section 1. There is hereby levied upon each dollar of assessed valuation in the county (except values subject to specific exemptions so stated above) for county-wide purposes as follows, to wit:

Current expenditures and maintenance taxes as fixed and limited by §27-39-303, 304, 317,327 and 395 of the Miss. Code of 1972, as amended thereof.

The levy of 18.33 mills for General Fund purposes is for the following items, in general, administration, judicial and public law enforcement, health and welfare services, operation and maintenance of buildings and grounds, as well as other sundry as approved in the overall General County budget to be finally adopted by the Madison County Board of Supervisors in accordance with the regulations set forth by the Mississippi State Audit Department in the Miss.
