In the Matter of Creating a Public Improvement District known as the Parkway East

ORDINANCE OF THE MADISON COUNTY BOARD OF SUPERVISORS CREATING A PUBLIC IMPROVEMENT DISTRICT TO BE KNOWN AS PARKWAY EAST AND OTHER MATTERS GERMANE THERETO

WHEREAS, pursuant to House Bill 1558, Mississippi Legislature 2002, all the landowners of property lying in a proposed public improvement district filed a petition to establish a public improvement district to be known as "Parkway East" before the Madison County Board on Supervisors on August 16, 2002; and

WHEREAS, the Board of Supervisors of Madison County, Mississippi, did cause a Notice of Public Hearing to run for the time and manner required by law four times in the <u>Madison County Herald</u> and further a hearing on the creation of the public improvement district was held at 10:00 A.M. on September 13, 2002, before the Madison County Board of Supervisors; and

WHEREAS, a copy of the description of the public improvement district "Parkway East" is attached to the Ordinance which is found in the miscellaneous file to these minutes and incorporated herein by reference; and

WHEREAS, the initial Board of Directors of the Public Improvement District "Parkway East" shall be Brad Sellers, Todd Cameron, Ken Wilbanks, Barry Parker and Helen Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI, that the Public Improvement District "Parkway East" is hereby created and the initial Board of Directors shall be Brad Sellers, Todd Cameron, Ken Wilbanks, Barry Parker and Helen Keller with the description of Parkway East being as follows, towit:

Commence at the SW corner of the NE ¼ of Section 6, Township 7 North, Range 2 East, Madison County, Mississippi and run S 89°40'53" E for a distance of 633.62 feet to an iron pin on the easterly right of way of Interstate Highway #55 as per Federal Aid Project # 1-55-2 (17)105, said iron pin is the Point of Beginning of the parcel herein described.
