NOW BE IT THEREFORE RESOLVED BY THE SUPERVISORS OF MADISON COUNTY, MISSISSIPPI that Madison County, Mississippi does hereby adopt a purchasing policy to include the requirement that all county personnel and departments receive approval of the Madison County Board of Supervisors for purchases of equipment, furniture or fixtures in any amount exceeding \$500.00 and that Board approval shall also be required for the purchase of any consumable supplies in any amount exceeding \$1,500.00 and that this policy shall be enforced by the Purchase Clerk and the Assistant Purchase Clerk of Madison County, Mississippi and that no purchase order shall be issued to any department or official if funds are not available within said department or officials budget.
