NOW BE IT THEREFORE RESOLVED BY THE SUPERVISORS OF MADISON COUNTY, MISSISSIPPI the Clerk is hereby authorized to issue a check in the amount of \$70.00 to the Forrest General Department of Public Safety for the Crisis Negotiation Class and to further issue a check in the amount of \$479.60 to Holiday Inn for the travel expense to the Crisis Negotiation Class as set forth above, and the Clerk is further authorized to issue a check in the amount of \$1,200.00 to the Rankin County Law Enforcement Officers' Training Institute for the Basic Jailer Training class as set forth above.
