MINUTES OF THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI

REGULAR MEETING OF SEPTEMBER 20, 2002 Recessed from regular meeting conducted on September 13, 2002

BE IT REMEMBERED that the regular meeting of the Board of Supervisors of Madison County, Mississippi was duly convened, held and conducted on the 20th day of September, 2002, at the Madison County Chancery/Administrative Building in Canton, Mississippi, as follows, to-wit:

The President of the Board, David H. Richardson, presided and called the meeting to order. The following members were present that day:

The President announced that the members of the Board present constituted a quorum and declared the meeting duly convened. Supervisor W.T. "Bill" Banks opened the meeting with a prayer and Sheriff Toby Trowbridge led the Pledge of Allegiance to the Flag of the United States of America.

In the Matter of Adopting an Ordinance Granting the Variance for William Irby

WHEREAS, William Irby filed a petition with the Board of Supervisors seeking a variance from the front setback requirements in a R-1 Residential District being located as a 2.1 acre tract in Section 3, Township 7 North, Range 1 East, Madison County, Mississippi; and

WHEREAS, Mr. Brad Sellers, Zoning Administrator, appeared before the Board of Supervisors and presented the petition and informed the Board that a variance of 25 feet in the 50 feet set back requirements was necessary due to the configuration of the property; and

WHEREAS, the Madison County Planning Commission had recommended the approval of this variance and no one appeared to object to its being granted.

Following additional discussion of this matter, Supervisor W.T. "Bill" Banks moved and Supervisor Karl M. Banks seconded a motion specifically finding that

a) that special conditions and circumstances exist which are peculiar to the land, structure or building involved in which are not applicable to other lands, structures, or buildings in the same district;

b) that the literal interpretation of the provision of this ordinance would deprive the applicant of rights commonly enjoyed by other properties in the same district under the terms of this ordinance;

c) that these special conditions and circumstances do not result from the actions of the applicant; and

d) that the granting of the variance requested will not confer on the applicant any special privilege that is denied by this ordinance to other lands, structures or buildings in the same district.

And the Board did specifically find that the reasons set forth above as stated in the petition justify the granting of the variance and that the variance is the minimal variance that will make possible the reasonable use of the land, structure or building and that the granting of the variance will be in harmony with the general purpose intent of the ordinance and will not be injurious to the neighborhood or otherwise detrimental to the public welfare. In the Matter of Granting a Special Exception for a Surface Mine Operation to be Conducted by Daniel Spivey

WHEREAS, Mr. Brad Sellers did present a Petition filed by Mr. Daniel Spivey seeking to conduct surface mining in an A-1 Agricultural District for a public hearing on said matter and informed the Board of Supervisors that the Madison County Planning Commission had recommended its approval.

WHEREAS, the matter was presented to the Board of Supervisors, and after conducting a public hearing thereon and a discussion thereof, Supervisor Paul Griffin did move the following ordinance be adopted, to wit:

BE IT ORDERED BY THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI, AS FOLLOWS:

- 1. That Daniel Spivey be allowed and granted a special exception to conduct surface mining in an A-1 Agricultural District on property owned by Mr. Spivey in Section 8, T9N, R3E, Madison County, Mississippi, and being further identified as parcel numbers 93C-8-11/01, 93C-8-15, 93C-8-16, 93C-8-17, 93C-8-18, 93C-8-19, 93C-8-20, 93C-8-21, and 93C-8-22 according to the most recent tax assessment records of Madison County.
- 2. The Board of Supervisors does hereby make the following findings certifying compliance with the specific rules governing this special exception and hereby finds that satisfactory provision and arrangement have been made concerning the following, to-wit:
 - a. Ingress and Egress to the property and proposed structures thereon with particular reference to automotive and pedestrian safety and convenience, traffic flow and control, and access in case of fire or catastrophe, the Board hereby finds that the conditions are acceptable for these properties.
 - b. Off-street parking and loading areas where required, with particular attention to the items noted above and the economic, noise, glare or odor effects of the special exception and adjoining properties and the properties generally in the district; the Board hereby finds that conditions are acceptable for this property.
 - c. Refuse and service areas, with particular reference to items noted above; the Board hereby finds that this is not applicable to this property.
 - d. Utilities, with reference to location, availability and compatibility; the Board hereby finds that utilities are available for this property.
 - e. Screening and buffering, with reference to type, dimensions and character; the Board hereby finds that this is not an applicable requirement for this property.
 - f. Signs, if any, and proposed exterior lighting, with reference to glare, traffic, safety, economic effect and compatibility in harmony to the properties in the district; the Board hereby finds that this is not applicable to this property and no requirement is made.
 - g. Required yards and other open space; the Board hereby finds that setbacks and open space are readily available for said property.
 - h. General compatibility with adjacent properties and other property in the district; the Board hereby finds that conditions for this property are generally compatible with adjacent properties and the conditions are acceptable.

In the Matter of Adoption of an Ordinance Re-zoning Property for and on Behalf of Sheffield Development, LLC

ORDINANCE BY THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI, AMENDING THE MADISON COUNTY ZONING ORDINANCE

WHEREAS, Sheffield Development, LLC. did file an Application to rezone certain property from its present A-1 Agricultural Use District Classification to an R-2 Residential Use District Classification; and

WHEREAS, the Board of Supervisors set a hearing for the 20th day of September, 2002, at 10:00 o'clock a.m., and the Clerk did cause Notice of said hearing to be published in the <u>Madison County Herald</u>, a newspaper published and of general circulation in Madison County, Mississippi, in the manner and for the time required by law; and

WHEREAS, the hour of 10:00 o'clock a.m. on the 20th day of September, 2002, did arrive; and

WHEREAS, there were no objections; and

WHEREAS, the matter was presented to the Board of Supervisors and after discussion thereof Supervisor W.T. "Bill" Banks offered the following Ordinance and moved that it be adopted, to wit:

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI, AS FOLLOWS, TO WIT:

That a material change in the circumstances has occurred in the area surrounding this property since the original zoning of this property and that the following described tract of real property be, and the same is hereby, rezoned from its present A-1 Agricultural Use District Classification to R-2 Residential Use District Classification, to wit:

Tract 1

A tract or parcel of land containing 255.793 acres and being located in Sections 29 and 30, Township 8 North, Range 3 East, Madison County, Mississippi, and being more particularly described as follows:

Beginning at a point on the South line of Yandell Road, sand point being 19.6 feet North of the corner common to Sections 19, 20, 29 and 30, Township 8 North, Range 3 East; run thence South 88 degrees 45 minutes East 659.87 feet along said South line of road; thence South 88 degrees 25 minutes East 659.99 feet along said South line of road; thence South 88 degrees 59 minutes East 660.0 feet along said South line of road; thence South 89 degrees 25 minutes East 660.00 feet along said South line of road; thence South 89 degrees 25 minutes East 660.00 feet along said South line of road; thence South 0 degrees 14 minutes 49 seconds West 2624.71 feet to an iron pin; thence North 89 degrees 58 minutes 31 seconds West 2624.0 feet to a concrete marker; thence South 424.7 feet along a fence to a concrete marker; thence North 89 degrees 57 minutes 29 seconds West 1357.13 feet along said fence to an iron pin; thence North 3110.0 feet to a point on the South line of road; thence South 88 degrees 20 minutes East 709.59 feet along South line of road; thence south 88 degrees 53 minutes East 659.93 feet along South line of road to the point of beginning.

That the Covenants and Plan for Stormwater Detention shall be filed with the Office of the Zoning Administrator of Madison County, Mississippi prior to any development on this property and that the homes constructed within this proposed area shall contain a minimum square footage of 1800 square feet and an average square footage of at least 2000 square feet.

That the Madison County Zoning Ordinance should be and the Zoning District Map should be and the same are hereby amended so as to reflect the foregoing change in the zoning of

the above described real property provided the plans and covenants are filed with the Office of the Zoning Administrator of said County.

In the Matter of the Zoning of Variance Requested by the Mississippi State Tax Commission/ ABC Division

WHEREAS, Mississippi State Tax Commission/ABC Division did previously file an application with the Board of Supervisors seeking a variance pursuant to Article 5 Section 504 of the Zoning Ordinance of Madison County, Mississippi and the Zoning Map adopted pursuant thereto and requesting a variance in the required side setback in a R-1 Residential District on property lying and being situated in Madison County, Mississippi as follows:

A tract of land located in Section 21, Township 8 North, Range 2 East, Madison County, Mississippi, further identified by tax parcel No. 82E-21-7, according to the latest Tax Assessor records of Madison County.

WHEREAS, the Board of Supervisors previously conducted a public hearing on said matter and closed said public hearing and then continued it until the 20th day of September, 2002; and

WHEREAS, the Board of Supervisors after having reviewed all of the information submitted by the Mississippi State Tax Commission now desires to grant said variance as requested.

d) that the granting of the variance requested will not confer on the applicant any special privilege that is denied by this ordinance to other lands, structures or buildings in the same district.

And the Board did specifically find that the reasons set forth above as stated in the petition justify the granting of the variance and that the variance is the minimal variance that will make possible the reasonable use of the land, structure or building and that the granting of the variance will be in harmony with the general purpose intent of the ordinance and will not be injurious to the neighborhood or otherwise detrimental to the public welfare. IT IS FUTHER PROCLAIMED AND ORDERED that all County agencies and departments shall render all possible assistance and discharge their emergency responsibilities as set forth in the County Emergency Operations Plan.
