In re: Request to Authorize Refund Upon Redemption Due to Excessive Assessment - Kathy Hill Parcel # 093D-19A-161/00.00

WHEREAS, Chancery Clerk Arthur Johnston did appear before the Board and presented the request of Ms. Kathy Hill, a senior citizen who received a determination of total disability by the Social Security Administration effective in 2003, and

WHEREAS, last term, the Board approved an amended homestead exemption application for the above-referenced taxpayer which has the effect of reducing the assessment of her property due to her complete disability under the Social Security Act, and

WHEREAS, Ms. Hill's disability status was determined as of 2003 and entitles her to a complete exemption from property taxes under the homestead laws beginning in 2004; however, she was unaware of her eligibility for the exemption and had delinquent taxes for 2004 (which sold at the 2005 sale) and for 2005 (which sold at the 2006 sale), both of which have now been redeemed, and

WHEREAS, Mr. Johnston reported that upon such redemption, and pursuant to Miss. Code Ann. § 27-73-7 (1972), the Board has the discretion to reduce the assessments for 2004 and 2005 to comport with the complete homestead exemption and to order the payment of a refund of the 2004 and 2005 raw taxes, but Ms. Hill is not entitled to a refund of the penalties or the interest after the date of the tax sales,
