Attached please find copies of our Term Bids.

Asphalt prices actually declined slightly. The price of SC-1, our primary re-surfacing asphalt, dropped from \$43.50 per ton to \$42.40 per ton. However, asphalt tends to lag six months behind the oil market, so we very likely could see an increase in asphalt prices with the next rounds of term bids effective 1 January 2008.

Gravel prices held stead; however, limestone prices are rising. The limestone we purchase is either transported from Kentucky to Vicksburg via barge or from the hills of Alabama to Meridian by truck.

I recommend that the Board take the following action:

- Award the Term Bids for CLAY GRAVEL AND WASHED ROAD GRAVEL, both picked-up and delivered, for the period 1 July 2007 – 30 June 2008 to HAMMETT GRAVEL COMPANY, ZEIGLERVILLE PLANT.
- Award the First Alternate Term Bids for CLAY GRAVEL AND WASHED ROAD GRAVEL, both picked-up and delivered, for the period 1 July 2007 – 30 June 2008 to HAMMETT GRAVEL COMPANY, YAZOO CITY PLANT.
- 3. Reject the lone Term Bid for Fill Dirt submitted by HAMMETT GRAVEL COMPANY for the period 1 July 2007—30 June 2008. The Road Manager does not foresee a need for this bid in that we are currently getting free fill dirt from the Flora area.
