### II. PROTESTS OF PERSONAL PROPERTY ASSESSMENTS

#### 1. AT&T Mobility, LLC.

WHEREAS, Mr. John Robinson, CPA appeared before the Board on behalf of AT&T and presented certain documentation supporting his contention that the personal property values at numerous AT&T Mobility locations were overstated and that certain technology supporting phones and phone systems was no longer in service and had little to no value and was completely obsolete, and

WHEREAS, Mr. Robinson argued that certain the 3G Broadband equipment should be exempt, and that certain other items of equipment were listed on the personal roll attributed to his company but did not actually exist, and

WHEREAS, Mr. Robinson also noted that, in his opinion, the Tax Assessor had applied the wrong industrial multiplier which resulted in an erroneously high valuation, and

WHEREAS, in response, Mr. Barber argued that his office had made several attempts to contact AT&T *via* certified mail requesting a listing of said company's inventory with no response, and

WHEREAS, Mr. Robinson acknowledged that his company had experienced some difficulties in keeping track of its equipment and personal property for tax and other purposes, and Mr. Robinson could not quantify or explain certain equipment photographed by the Tax Assessor apparently kept in a secured status,
