In re: Request of Louis B. Gideon/Plantation Millworks to Rezone Certain Property From C-1 Commercial to C-2 Commercial

ORDINANCE BY THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI, AMENDING THE MADISON COUNTY ZONING ORDINANCE

WHEREAS, the Board of Supervisors had previously advertised its intent to conduct a public hearing concerning the petition of Louis B. Gideon and Plantation Millworks, LLC seeking rezoning of property, pursuant to the Zoning Ordinance of Madison County, MS, and to amend the Zoning Maps adopted pursuant thereto, by requesting property be rezoned from C-1 Commercial District to a C-2 Commercial District.

WHEREAS, the Board authorized the publication of notice in the *Madison County Herald*, a newspaper of general circulation in Madison County, the same having been accomplished on June 3, 2004, and

WHEREAS, a true and correct copy of said Notice is attached hereto as Exhibit B, spread hereupon, and incorporated herein by reference, and

WHEREAS, the hour of 9:00 a.m. did arise and County Zoning Administrator Brad Sellers and Mr. Louis B. Gideon did appear before the Board for a public hearing seeking to rezone a certain C-1 Commercial District to a C-2 Commercial District, and

WHEREAS, the Board President declared said public hearing to be open as noticed, and

WHEREAS, Mr. Gideon did appear before the Board and explained that he intends to build a retail millworks store on the subject property and is in need of re-zoning of thereof to accomplish this goal, and

WHEREAS, the Planning and Zoning Commission did recommend approval of the request, and

WHEREAS, no one appeared in opposition thereto, despite the giving of full and proper notice hereof,

Following discussion, Mr. Andy Taggart did move and Mr. Paul Griffin did second a motion to close the public hearing, grant the request and adopt the following Ordinance, to-wit:

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI, AS FOLLOWS, TO WIT:

1. That appropriate public need and change in character of the neighborhood having been demonstrated, the following described tract of real property be, and the same is hereby, rezoned from its present C-1 Commercial District to a C-2 Commercial District:

A parcel of land lying and situated in Section 29, T8N-R2E, Madison County, Mississippi, more particularly described as follows:

Commence at an iron pin representing the intersection of the east line of Section 29 with the southerly right-of-way of Gluckstadt Road and run thence 00 degrees 22 minutes 30 seconds E for a distance of 1494.12 feet to an iron pin representing the Northeast corner of that parcel of land described in Deed book 402 at Page 681; thence run S 00 degrees 22 minutes 30 seconds E, along the easterly line of said parcel, for a distance of 301.87 feet to an iron pin which is the Point of Beginning of the parcel herein described. From the Point of Beginning run thence N 88 degrees 41 minutes 15 seconds W for a distance of 310.56 feet to an iron pin at the southwest corner of said parcel of land described in Deed Book 402 at Page 681; thence run N 82 degrees 30 minutes 46 seconds W along the northerly line of that parcel of land described in Deed Book 402 at Page 683, for a distance of 134.11 feet to an iron pin; thence run S 00 degrees 22 minutes 30 seconds E for a distance of 221.04 feet to an iron pin on the southerly line of said parcel; thence run S 89 degrees 09 minutes 44 seconds E, along the southerly line of said parcel, for a distance of 342.98 feet to an iron pin on the westerly right-of-way of U.S. Interstate 55; thence run northwesterly along said right-of-way and the arc of a curve to the right having a radius of 3669.72 feet, a delta angle of 02 degrees 06 minutes 47 seconds, a chord bearing of N 47 degrees 30 minutes 05 seconds E, a chord length of 135.32 feet, and an arc length of 135.33 feet, for a distance of 135.33 feet to an iron pin at the southwest corner of that parcel of land described in Deed Book 434 at Page 138; thence run N 00 degrees 22 minutes 30 seconds W, along the westerly line of said parcel and the easterly line of said parcel of land described in Deed Book 402 at Page 683, for a distance of 76.31 feet to an iron pin at the southeast corner of that parcel of land described in Deed Book 402 at Page 681; thence run N 00 degrees 22 minutes 30 seconds W along the easterly line of said parcel for a distance of 33.72 feet to the Point of Beginning. This parcel contains 2.00 acres more or less, and is situated within and a part of those parcels of land described in Deed Book 402 at Page 681 and Deed Book 402 at Page 683.

2. That the Madison County Zoning Ordinance be and the Zoning District Map be and the same are hereby amended so as to reflect the foregoing change in the zoning of the above described real property.

In re: Petition of Lonnie Harris for a Special Exception to Continue to Conduct Surface Mining Operation

WHEREAS, on May 21, 2004, in open session, the Board of Supervisors agreed to reconsider at a later date the Petition of Lonnie Harris for a Special Exception to Continue to Conduct Surface Mining Operation in an A-1 District on Acey Minter Road, more particularly described as 15 acres located in the NW 1/4 of the NE 1/4 of Section 8, T9N-R4E, Madison County, Mississippi, further identified by Parcel # 94C-08-010, and

WHEREAS, Mr. Harris and his attorney, Danny Spivey, did appear before the Board and explained that Petitioner has an existing mining operation on this property, that an application has been made to MDEQ for a 15 acre expansion of his mining operation, and that Petitioner has proposed providing asphalt to pave 1400 feet of Acey Minter Road to eliminate dust and improve the road for the residents in the area, and

Following discussion, Mr. Andy Taggart did move and Mr. Paul Griffin did second a motion to grant the special exception with the following conditions: (1) Petitioner immediately supplying the Road Department with all materials necessary to pave 1400 feet of Acey Minter Road from its intersection with Highway 16 so that such paving can be accomplished during the current paving season; (2) Petitioner adhering to the hours of operation adopted for the surfacing mining operation on Robinson Springs Road approved by this Board in January, 2004 for APAC of Mississippi; and (3) Petitioner completing the reclamation of his surfacing mining operation on Robinson Springs Road to the satisfaction of the Mississippi Department of Environmental Quality and this Board no later than December 31, 2004; (4) Petitioner appearing before the Board annually to review the operation. Said motion further provided that, at the end of a three month period from today's date, the permit would expire if requirements (1) and (2) above have not been completed within ninety (90) days from the date hereof. WHEREAS, President Jones did report that he and County Administrator Donnie Caughman had conferred in advance of the meeting as to certain matters denominated "Consent Items" on the Agenda and that the same appeared to be routine, non-controversial items with which all Supervisors were likely to agree, and

WHEREAS, Mr. Caughman did explain that any Supervisor could, in advance of the call of the question, request that any item be removed from the Consent Agenda, and

WHEREAS, the following items were taken up as "Consent Items," to-wit:

(A) Approval of Increase in Assessment of Real Property 2003 Roll - Baltic LLC

WHEREAS, Tax Assessor Gerald Barber through Chief Deputy Tax Assessor Kent Hawkins presented a Notice to Increase the Assessment of Real/Personal Property pertaining to Parcel No. 72I-30C-5/1.13 assessed to Baltic LLC in order to correct land and building values and to increase the total assessment to \$29,235, and

WHEREAS, Kelly Dabbs, a principal in Baltic LLC, did, on June 22, 2004, execute the aforesaid notice, a true and correct copy of which is attached hereto as Exhibit G, spread hereupon, and incorporated herein by reference, and did thereby indicate the owner's acceptance of said increase and has expressed his desire to resolve the issue as soon as possible,

WHEREAS, the Board does desire and intend to approve the increase in assessment as requested by the Tax Assessor and Baltic LLC in the amount and for the reasons as set forth in, the aforesaid Exhibit G, and

(B) Approval of Eight (8) Certain Utility Permits

WHEREAS, County Engineer Mike McKenzie did appear before the Board requesting approval of permits allowing use and occupancy for the construction or adjustment of a utility within certain roads or highway rights of way, and

WHEREAS, said permits were as follows:

- (1) Entergy seeking to add a second phase along an existing route along Old Highway 51 from Highway 17 to Church property in section 25 T12N-R3E through section 35 T12N-R3E
- (2) Entergy seeking to install new lines along existing pole line along Bozeman Road from Sharpe Road to Gluckstadt Road
- (3) Entergy seeking to install two inch bores for underground electrical cables crossing Stribling and Deweese Roads to serve Ashbrooke Subdivision in section 13, T8N, R1E
- (4) Entergy seeking to install one 15 KV single phase primary line at one point on Strong Road in section 2 T8N, R2E
- (5) Entergy seeking to install overhead guys on Stribling and Deweese Road and three phase primary lines across Deweese Road in section23, T8N-R1E
- (6) Time Warner Cable seeking to place underground CATV cable via trenching and boring along Caroline Crossing in section 14 T8N-R1E

- (7) Town of Flora seeking to install a 16 inch diameter steel casing and carrier pipe across the C & N Railroad parallel to Kearney Park Road in section 5, T8N, R1W
- Bellsouth seeking to place phone cable along Petrified Forest Road in section 20, T8N, R1W, and

WHEREAS, a true and correct copy of each of the above and foregoing permit applications may be found in the Miscellaneous Appendix to these Minutes, and

WHEREAS, the Board does desire to approve each of said applications, and

(C) Authorizing the Giving of Public Notice of the Intent of the Board of Supervisors to Conduct a Public Hearing On Petitions to Amend/Change the Official Zoning Ordinances and/or Official Zoning Map of Madison County, Mississippi

WHEREAS, County Zoning Administrator Brad Sellers did present the Board of Supervisors with the following petitions to amend/change the Official Zoning Ordinances and/or Official Zoning Map of Madison County, Mississippi, as follows and recommended that the Board authorize the giving of public notice of its intent to conduct public hearings on said petitions at 9:00 a. m. on the 23rd day of July, 2004, to-wit:

(1) Madison County Schools - Petition for Special Exception Public/Quasi-Public Facility.

(An elementary school is proposed on this property.) *Location:* Highway 43 North, Section 6, TI0N-R2E. *Data:* Madison County Schools propose a new elementary school on this 24.97 acre tract. The Madison County Zoning Ordinance provides two methods for educational facilities, SUI District, or as a Special Exception. Water service is available, design plans for the wastewater treatment are at MDEQ for review.

 Bruno Clark - Petition to Rezone R-I Residential to C-2 Commercial District. *Location:* Highway 51, Section 27, T8N-R2E. *Data:* Petitioner wishes to rezone this property to develop a commercial shopping center. A site plan is provided, depicting flood plain and floodway, with building foot prints. Water and sewer provided by Bear Creek.

(3) Diane Bennett - Petition to rezone R-I Residential to C-2 Commercial. Location: Pine Drive off Livingston-Vernon Rd. Data: This tract contains acreage, with an existing warehouse on site. Petitioner proposes C-2 zoning to conduct a business at this location. There have been other non-conforming commercial uses at this location. Information provided regarding usage of this building, along with proposed restrictions.

(4) **Brenda Hales** - Petition for Special Exception to place mobile home in an R-2 District.

Location: 130 Terri Road, Kearney Park area, Section 32, T9N-RIW. *Data:* Petitioner wishes to purchase this property and place a mobile home for residential use. There are other mobile homes on this street. Sanitary sewer is available.

(5) Riley Wayne McFarland - Petition to place mobile home in an R-I District. Location: 120 Old Hwy 16, Sharon area, Section 6, T9N-R4E. Data: Petitioner wishes to replace an old mobile home with a newer model. Mr. McFarland has lived here in a mobile home for 20 years. Water and sewer exist on the propety, and

WHEREAS, Mr. Sellers did also request that the Board set July 23, 2004 at 9:00 a.m. as the date and time for public hearings concerning certain zoning violations

alleged against T. M. Roberts, John Green and Sherry Lott and grant him authority to publish notice accordingly, and

WHEREAS, the Board does desire to set each of said matters for public hearing on the date and time set forth above and does desire to authorize Mr. Sellers to issue notices accordingly.

(D) Authorizing the Giving of Public Notice of the Intent of the Board of Supervisors to Conduct a Public Hearing On the Proposed Amendment to the County's Solid Waste Master Plan Pertaining to the Foshee Class II Rubbish Facility

WHEREAS, County Zoning Administrator Brad Sellers did appear before the Board and requested that the Board set August 20, 2004 at 9:00 a.m. as the date for a hearing on the proposed amendment to the county's Solid Waste Master Plan pertaining to the Foshee Class II rubbish facility rather than July 23, 2004 as ordered by this Board on June 18, 2004, and that he be authorized to give proper notice thereof, and

WHEREAS, the Board does desire to grant said request and set the matter down for a hearing on said date, and

(E) Approval of Grant Agreement with the Mississippi Department of Environmental Quality Pertaining to the Cleanup of Unauthorized Dump Sites

WHEREAS, County Administrator Donnie Caughman did present the Board with correspondence dated May 26, 2004 from the Mississippi Department of Environmental Quality indicating that the MDEQ has approved the county's solid waste assistance grant request, and
