WHEREAS, the notice of said hearings was published in the *Madison County Herald*, a newspaper of general circulation in the county, said publication having occurred on August 23, 2012 and August 30, 2012, as required by law and as reflected on the Proof of Publication thereof, a true and correct copy of which is attached hereto as Exhibit C, spread hereupon and incorporated herein by reference, and

Brewer over the weekend and that Judge Brewer had authorized certain reductions in the budgets of his office, the Chancery Court and the Mental Health Court which he presented those to the County Administrator,

Following discussion, Mr. Gerald Steen did offer and Mr. Karl M. Banks did second a motion to set and establish the levies and millage rates for the county as set forth on Exhibit D, spread hereupon and incorporated herein by reference, the same reflecting an increase in the solid waste fund by 1.3 mils, the fire protection fund by .7 mils and the county general fund by .5 mils, with all other millage rates to remain the same as FY 2012.
