Subject: Award bid for sale of six Mack garbage trucks to Waste Pro at the price of \$1,002,000 and authorize administrator to execute titles to said company

Dear Board Members:


Bids were opened on April 8 for the sale of the county's six garbage trucks. The bids were as follows:

Waste Pro	\$1,002,000
Waste Management	\$900,753
Tri State	\$840,000

The county paid \$1,148,748 for the six trucks in May 2015, which means as of the end of April the county will have used the trucks about one year. Waste Pro's bid price is \$146,748 less than we paid for the six trucks. That translates to a price depreciation of 12.77 percent in the truck's first year of operation.

I recommend that the board award the bid for the sale of six Mack garbage trucks with McNeilis bodies to Waste Pro at the price of \$1,002,000, with the sale to be consummated at the close of business on April 29 or as soon thereafter as possible. I further recommend that the board authorize the administrator to execute the titles to Waste Pro upon receipt of a check in the amount of \$1,002,000.
