Subject: Authority to Advertise for Term Bids

Dear Board Members:

State law allows counties to advertise for and then award term bids for the purchase of commodities and construction services. An awarded term bid locks-in the price of the commodity or construction service for the duration of the term bid period and removes the need to advertise or get quotes for each individual purchase that exceeds a purchasing threshold (two quotes are normally required for purchases greater than greater than \$5,000; advertising is generally required for purchases greater than \$50,000 except for state contract items). The standard requisition and purchase order safeguards are still required when using term bid pricing.

Term bids are primarily used by the Road Department; however, other departments such as Buildings and Grounds and Parks will occasionally use them.

Most county term bids are for a one-year period, which corresponds with the fiscal year. Due to the volatility of oil prices, the county tends to get lower prices for asphalt and asphalt-related products and services when using a shorter six-month term bid period.
