- Add the Minutes for the Pre Bid Meeting.
- 2. Change NTB # 7001-Contract Time is revised so that the effective date of the Notice to Proceed/Beginning of Contract Time will be 4 months instead of 3 months following the Date of the Notice of Execution of the Contract Letter.
- Add NTB #7702 LPA-Project Number Change from STP-0045-00(024) LPA/106482-701000 to Project Number STP-0045-00(027) LPA/106482-701000 to the TOC and body of the contract
- 4. Add NTB #7703 LPA-To require the contractor to establish elevations in areas where extensive curb and gutter will be required.
- 5. Change the Unit of Measure from EA to LF for Pay Item 619-G4005- Barricades, Type III, Double Faced, on Bid Sheet and OPC.

- 6. Add 2,900 LF of 609-D006-Combination Concrete Curb and Gutter Type 1 Modified, on Highland Colony Parkway (modified to 6" curb instead of 8" curb) on Bid Sheet and to the OPC and the Summary of Quantity Sheet.
- Reduce 5,900 LF of Pay Item 609-D005 -Combination Concrete Curb and Gutter Type 3B Modified to 3,000 LF on Bid Sheet, the OPC and Summary of Quantity Sheet, due to above change.
- 8. Add Sheet No. 6287 (Driveways, Curb and Gutter and Sidewalk) to the plans.
- 9. Add above Sheet No. 6287 to Detailed Index Sheet
- 10. Change the note on Sheet 31 to read the lamp and line will be removed by others.
