Dear Mr. Genin:

- \*1 Attorney General Mike Moore has received your letter of request and has assigned it to me for research and reply. Your letter states:
- \*1 Night shift and weekend officers place subjects in jail for D.U.I.'s and other crimes during their shift when judges and court clerks are not available to take their oath on tickets or affidavits. When the judges and the court clerks are available the officer is off duty and at home sleeping. This leads to my question. Can dispatchers become notary publics or deputy clerks and take and sign oaths on tickets and affidavits?
- \*1 Would your answer apply to both tickets and affidavits returnable to justice court and municipal court?
- \*1 In response, I have attached a prior opinion of this office, MS AG Op, Griffith (January 27, 1986) which addresses your question. That opinion states that a dispatcher may, if appointed, also serve as a deputy clerk for the purpose of taking oaths on tickets and affidavits. This would apply to both justice court and municipal court.

Dear Mr. Griffith:

- \*1 Attorney General Edwin Lloyd Pittman has received your letter and has assigned it to the undersigned for research and reply. In your letter you state:
- \*1 \*On behalf of the Bolivar County Board of Supervisors, I respectfully request an opinion from your office responsive to the following question, which I have already discussed with Special Assistant Attorney General Ryan Hood.
- \*1 Does the Board of Supervisors have the legal authority to appoint a dispatcher and I Deputy Sheriff in the Sheriff's Office to serve as Deputy Clerk of the Justice Court of the county for the specific purpose of receiving and receipting monies, acknowledging affidavits, issuing warrants in criminal cases upon direction by a justice court judge in the county and discharging all other duties and responsibilities as are vested in Deputy Justice Court Clerks pursuant to Mississippi Code, Annotated, § 9-11-27 (Supp. 1985), with such Deputy Justice Court Clerk serving only during that period of time which is not included in the regular business hours of the justice court system, namely, between 5 p.m. and 8 a.m. on weekdays, and from 5 p.m. Friday until 8 a.m. on Monday and weekends.
- \*1 "No additional salary would be paid to the dispatcher and lor deputy sheriff serving as such deputy justice court clerk, the primary function of which would be to handle and conduct at nighttime and on weekends those ministerial actions that would otherwise be performed by the justice court clerk during normal business hours.
- \*1 "My research and analysis of the relevant statutory and constitutional authorities has included Mississippi Code, Annotated, §§ 9-11-18, 9-11-21 and 9-11-27 (Supp. 1985), and Mississippi Constitution, Article 1, Section 1 (1890), those authorities indicating that the Board 'may appoint such other employees for the justice court of the county as it deems necessary, including a person or persons to serve as deputy clerk or deputy clerks,' with specific statutory responsibilities for the clerk or deputy clerks to utilize uniform receipts on forms prepared by the Attorney General's Office and to utilize the justice court clerk clearing account for deposits of certain monies deposited with the justice court. It would also appear that in view of the solely ministerial functions which we anticipate would be performed by such a 'nighttime and weekend' deputy justice court clerk, there would be no constitutional prohibition so long as the dispatcher and for deputy sheriff also serving as such deputy justice court clerk did not receive an additional salary for the same hours work."
- \*1 In response to your letter, this office is of the opinion that your legal analysis and conclusion is correct in that a county board of supervisors, in their discretion, may employ an individual serving as a deputy sheriff or radio dispatcher as a part-time justice court clerk deputy within the limitations put forth in your letter.
