We are pleased to submit to you our bid tabulation for the Roadways of Reunion Parkway and Highland Colony Parkway project. Bids were received and opened at Madison County Chancery Clerks Office on Wednesday, July 27, 2016 at 10:00 AM. A copy of the Certified Tabulation of Bids is attached.

Three bids were submitted ranging in total amounts from \$4,342,628.50 to \$5,319,301.46. The low bidder was APAC-Mississippi, Inc. with a total bid amount of \$4,342,628.50. The Opinion of Probable Cost was \$4,904,365.00. The low bid was 11.5% under the Engineer's Estimate (see attached). The proper proposal documentation, including bond, appears to be in order as required by the contract documents.

Therefore, we recommend that award of the contract be made to APAC-Mississippi, Inc. in the amount of \$4,342,628.50. Our recommendation of contract award as stated herein is made subject to availability of funds.
