*1 Attorney General Jim Hood has received your opinion request and has assigned it to me for research and reply.

INQUIRY

*1 May the **county** pay the cost of wellness incentives, specifically, may the **county** pay the cost of **flu shots** for its employees as part of an overall program to improve the health of **county** employees?

RESPONSE

*1 Yes, upon the requisite finding by the Board of Supervisors, spread upon its minutes, that such expenditure is necessary and accrues to the benefit of the **county**, the board may pay the cost of **flu shots** for its employees.

*1 We issued an opinion to Mr. David Hunt in 2000 opining that the Clarksdale Public Utilities Commission could pay for flu shots for its employees upon a finding that such is necessary to serve the public interest. MS AG Op., Hunt (October 27, 2000). I have included for your review several other opinions which we have issued regarding governing authorities paying for various health-related benefits for their employees. MS AG Op., Nowak (March 17, 2006); MS AG Op., Sorrell (January 28, 2005); MS AG Op., Sollie (July 22, 2005); MS AG Op., Twiford (January 7, 2000). (Note that the 2005 Sollie opinion was modified and restricted in part by the 2006 Nowak opinion.)
