Re:

Holiday Time - Sheriff's Office

As you know, the Sheriff's Department is required to operate 24 hours per day for each day of the year. It is routine and expected that Sheriff's employees will work on days that are declared holidays.

This earns an employee the right to additional pay or time off (commonly called comp time) for working a declared holiday. This creates a financial liability by the county to the employee.

I recommend that this outstanding liability be paid to the employees of the Sheriff's Department and to one former Sheriff's employee who has not been paid for this holiday time. Additionally, as this should have minimal budget impact, I recommend that holiday time be paid as it is earned in the future.
