Thank you for your time and guidance in discussing the above-referenced property in connection with a proposed new business in Madison County. Pursuant to your request, we submit the following:

On the Hoof, L.L.C. is a deer processing company doing business as Prime Time Deer Processing. We currently have a large processing facility located in Jackson, Mississippi on the South I-55 Frontage Road about a mile south of the Byram exit. This is a 7,000 square foot processing facility capable of processing in excess of 20,000 deer per year. We also currently have two "drop off, pick up" locations in Bolton, Mississippi and Vicksburg, Mississippi. At the "drop off, pick up" locations the deer are dropped off and stored in our portable cooler (53 foot reefer) until they can be transported (at least within 2 days) to our processing facility in Jackson. The meat is then processed and transported back to the "drop off, pick up" location for the customer to pick up. This is somewhat similar to a dry-cleaning location where the services are performed elsewhere. No processing takes place at the "drop off, pick up" locations.

We propose to locate a "drop off, pick up" location at the above-referenced location. We would like to open as soon as possible and remain open until the end of February. At that time, we would remove both of our portable structures. We require a 53 foot reefer trailer and a portable office location. These buildings will be oriented as noted on the attached drawing. Additionally, we have added several pictures of our other locations as illustrations of our business.

The business activity, while not specifically listed under C-2 zoning, is a service company that is similar to current allowed C-2 service companies. Additionally, the portable buildings are allowable and consistent with (Q) under the C-2 classification of the Madison County Zoning Ordinance.

We propose a sign of 32 square feet per side at the road consistent with Section XXVII of the Madison County Zoning Ordinance. We request that the sign be illuminated for the safely and convenience of our customers because we will be open until 8:00 p.m. each night. Our business hours will be 9:00 a.m. to 8:00 p.m., Monday

through Saturday and 2:00 p.m. to 8:00 p.m. on Sunday. We also enclose a copy of our menu of services provided for your convenience. Our plan is to locate in a permanent building in the Gluckstadt area next year, possibly in the current above-referenced location.







Madison County Web Map
