Please be advised that based on the fact that West Madison Utility District ("WMUD") now has a company hired as its Operator to handle the day to day operations of water/sewer service issues, and no longer has in house employees managing these services, WMUD approved declaring the following items surplus property at its October 21, 2016 Special Board meeting:

1999 Heavy Duty Trailer, VIN#12HZD3020XS097774.

It was further recommended that these items be donated back to Madison County in order for Madison County Road Department to put them back in service. It is further WMUD's request that in exchange for this donation, that the Madison County Road Department assist WMUD with the removal of debris located on its property at 443 Livingston Vernon Road in the Kearney Park area (remainder of an old mobile home that the Fire Department will burn, old concrete, cast iron and pvc pipe, broken generators, broken aerator, broken tables, broken filing cabinets, etc.,....).
