


IN THE CHANCERY COURT OF MADISON COUNTY, MISSISSIPPI

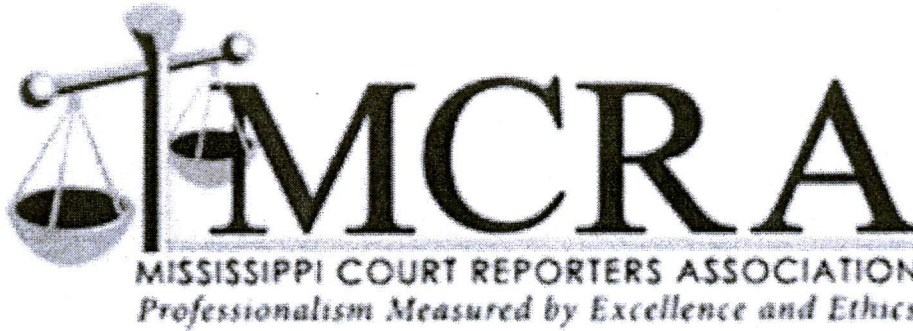
