Dear Scott:

Chad Trigg requested some information concerning fire flow capabilities on a parcel on the north side of Gluckstadt Road. The parcel is east of the Shell/Pizza Hut/Steak Escape, and west of the Gluckstadt Animal Hospital. Our computerized hydraulic model of our water system shows pressures in that area to be within the recommended pressure range set by the Mississippi State Department of Health (20-80 PSI recommended). Also, due to our 16" waterline on the north side of Distribution Drive, our hydraulic model shows that the fire hydrants will produce an adequate flow for fire protection purposes.


The closest fire hydrants are at the southwest corner of the Shell/Pizza Hut/Steak Escape parcel, and also directly across the street (on the south side of Gluckstadt Road) from the subject parcel.
