Subject: Proposals for Rights of Way Mowing and Spraying

Dear Board Members:

Late last year the board directed that the county advertise for requests for proposals for mowing and spraying roadside rights of way. Two proposals were received: one for mowing and spraying and one for spraying only. Copies of the proposals along with tabulations and estimate sheets are attached.

As you can see from the last line on the attachment entitled *Mowing and Spraying Rights of Way Tabulation*, the Road Department is mowing rights of way for approximately one-half of the cost of Rotolo's proposal.

As to the proposals for spraying rights of way only while continuing to mow using Road Department resources, the lowest price was submitted by Helena Chemical. Please see the attached sheet entitled *Spraying Rights of Way Tabulation*. I calculated the base proposals to show the cost of three sprayings per year for one mile, 200 miles, 300 miles, 400 miles, and 500 miles.

Based upon my research and the people with whom I have communicated, spraying offers the greatest potential to reduce mowing needs and produce long-term cost savings. Upon the recommendation of the Helena Chemical salesman, I telephoned Oktibbeha County Road Manager Victor Collins (662-418-3423) to inquire about his county's reduced mowing needs resulting from its spraying program. Mr. Collins stated that before implementing a spraying program about four years ago, the county mowed roads five times per year. He said the county now mows roads once or twice a year, with the first cutting beginning shortly before July 1. I would recommend that the board consider implementing a spraying program. The low cost of spraying could be offset by the savings from a reduced number of needed annual mowings in the future.
