**ORDER REGARDING
SUPPLEMENTAL PUBLIC DEFENDER COMPENSATION**

THIS MATTER is before the Court regarding the supplemental compensation of Lindsey U. Herr in her capacity as Juvenile Drug Court Public Defender in the amount of \$10,000.00 annually, solely from funds provided by the Department of Public Safety as a result of increased funding from a Justice Assistance Grant and not from funds provided by Madison County, Mississippi. After the Court being so advised in the premises, the Court is also aware of the:

1. entry of an order in the Circuit and County Courts of Madison County, Mississippi on October 1, 1984, that addressed the matter of representation of indigent defendants in Madison County, Mississippi;

2. entry of an order in the Circuit Court of Madison County, Mississippi on September 15, 2014, consistent with the order entered on October 1, 1984, and also regarding the matter of representation of indigent defendants in Madison County, Mississippi; and

3. entry of an Order Appointing Public Defender in the Circuit and County Courts of Madison County, Mississippi on January 3, 2017, Appointing Lindsey U. Herr as a public defender in the County Court of Madison County, Mississippi consistent with the above-mentioned orders.

Accordingly, the Court finds that effective January 1, 2017, Lindsey U. Herr, in her capacity as Juvenile Drug Court Public Defender should receive supplemental compensation in the amount of \$10,000.00 annually, solely from funds provided by the Department of Public Safety as a result of increased funding from a Justice Assistance Grant and not from funds provided by Madison County, Mississippi and for such services should receive the additional monthly sum of \$833.33, subject to income tax withholding and with no additional benefits, with the first payment to be due

on January 31, 2017.

IT IS THEREFORE ORDERED AND ADJUDGED that effective January 1, 2017, Lindsey U. Herr, in her capacity as Juvenile Drug Court Public Defender, should receive supplemental compensation in the amount of \$10,000.00 annually, solely from funds provided by the Department of Public Safety as a result of increased funding from a Justice Assistance Grant and not from funds provided by Madison County, Mississippi, and for such services should receive the additional monthly sum of \$833.33, subject to income tax withholding and with no additional benefits, with the first payment to be due on January 31, 2017.
