Notice of Award

In May 2016, Neel-Schaffer presented a study that provided a planning level of traffic circulation of selected arterial roadways in South Madison County to help prioritize roadway improvements where the traffic demands are the highest. As a result, one of the short term improvements that came from the study was:

- US Highway 51/Yandell Road-widen east approach.

Since that time, the County has moved forward with the recommendation. On February 21, 2017, sealed bids were received for construction. The lowest bid was submitted by Southern Rock, LLC in the amount of \$849,955.70. Therefore, the Engineering Department recommends the Board to approve and award the bid to Southern Rock, LLC for construction of Yandell Road Improvements.
