## Public Notice Amendment of Hinds County Solid Waste Management Plan

The Hinds County Board of Supervisors is considering a request from Partridge Sibley Industrial Services, Inc. (4273 I-55 North, Jackson, MS 39047) to amend the Hinds County Solid Waste Management Plan to add land application sites for biosolids. The land application involves disking in biosolids at sites southwest of Raymond, Miss., between Highway 18 and the Natchez Trace Parkway; and at sites in the southeast corner of Hinds County, generally between I-55 and the Pearl River at the border of Hinds County and Copiah County. More specifically, the sites are

- (1) 18168 Old Port Gibson Rd; Sections 25 and 26, Township T5N, Range R3W; total area of about 63 acres and disposal area of about 33 acres.
- (2) Old Port Gibson Road at intersection with Short Road; Sections 25, 26, 35, and 36, Township T5N, Range R3W; total area of about 388 acres and disposal area of about 200 acres.
- (3) Old Port Gibson Road at intersection with Dupree Road; Section 33, Township T5N, Range R3W; total area of about 176 acres and disposal area of about 83 acres.
- (4) Moncure Marble Road at the intersection of Jack Johnson Road; Sections 27 and 28, Township T3N, Range R1W; total area of about 400 acres and disposal area of about 170 acres.
- (5) Moncure Road, Moncure Marble Road, and Jack Johnson Road; Sections 34, 35, and 36, Township T3N, Range R1W; total area of about 617 acres and disposal area of about 405 acres.
- (6) 5000 Moncure Marble Road; Sections 33, 34, and 35, Township T3N, Range R1W; total area of about 503 acres and disposal area of about 350 acres.

The waste to be land applied is biosolids removed from the City of Jackson's Savanna Street and Trahon wastewater treatment plants.
