Subject: Mowing and Spraying Rights of Way Proposals

Dear Board Members:

Following the February 21 board meeting, Danny Lee and Amber Pope, representing County Engineer/Road Manager Dan Gaillet, and I meet with Rotolo's representatives to afford the company an opportunity to reduce the price of its proposal.

Rotolo's original proposal for mowing all county rights of way was \$1,178,635. The original proposal included four county-wide cutting cycles plus 16 zero-turn cutting cycles on selected roads and intersections. It also included litter control prior to cutting.

Rotolo's amended proposal is \$647,170. It basically includes all elements of the original proposal except for the following: (1) rural and state aid roads reduced to three cuttings; (2) zero-turn cuttings reduced to 12; and (3) all litter control deleted.

The Road Department's estimated mowing cost (litter control removed to match Rotolo's amended proposed) is approximately \$500,000. That is approximately \$150,000 less than Rotolo's amended proposal.

Mr. Gaillet and I discussed the proposal and agree that the best course at present is for the Road Department to mow this season while at the same time keeping accurate records of all mowing costs and the number of the mowings. Then, if the board wishes to revisit mowing next winter, we would have accurate data to make an apples-to-apples comparison.

SPRAYING

As to the proposals for spraying rights of way only, the lowest price was submitted by Helena Chemical. Please see the attached sheet entitled *Spraying Rights of Way Tabulation*.

Mr. Gaillet and I recommend that the board consider implementing a spraying program. The low cost of spraying could be offset by the savings from a reduced number of mowing cycles in the future. If approved today, Helena Chemical could begin spraying within the next two weeks.


URBAN AREA AS DEPICTED ON MAP



To Whom It May Concern:

We are pleased to present the following revised pricing for the above noted RFP.

Below we have summarized the changes to the original specifications:

- Removed litter removal from scope of work
- Reduced the mowing frequency in the Rural and State Aid Rural areas from 4 to 3 cycles per year
- Reduced the mowing frequency in the Zero-Turn and Edging areas from 16 to 12 cycles per year
- Adjusted scope on East Parkway to include zero- turn mowing of the medians and 12' on each shoulder which will be performed 12 times per year. Outside of the 12' strip on the shoulders will now be bush hogged 4 times per year

The new annual price for mowing and spraying operations will be:

- \$647,170 Mowing
- \$140,144 Spraying

We have also attached a revised bid tabulation sheet which provides a breakdown of our pricing based on these changes in scope as well as internal reductions in our pricing.
