**NON-EXCLUSIVE  
ELECTRICAL SERVICE CONTRACT**

This Electrical Service Contract is made and entered into on this the 7<sup>th</sup> day of March 2017 by and between **MADISON COUNTY, MISSISSIPPI** (hereinafter called the "County"), and **OMEGA ELECTRIC** (hereinafter called the "Contractor").

In consideration of the following mutual agreements and covenants, the parties agree as follows:

1. The Contractor agrees to perform electrical services for Madison County as detailed on the attached quote sheet, a copy of which is made a part of this contract by reference.
2. The Contractor shall supply all labor, equipment, and transportation necessary to perform the electrical services.
3. This is a non-exclusive contract. All electrical services shall be performed on an as-requested basis only.
4. This contract shall be for a period of one year and shall automatically renew each year on the contract anniversary date unless one party provides the other party with 60-days written notice of its decision not to renew said contract.
5. Either party may cancel this contract, with or without cause, upon 60-days written notice to the other party.

**SCOPE OF WORK:**

**OMEGA ELECTRIC** will provide licensed electrician(s) to perform electrical repair(s) or new electrical service(s) for Madison County. This Service Contract is for labor, equipment, and transportation necessary to perform the electrical services required to complete the project. It should be understood that Madison County has multiple facilities located throughout the county.

Any material needed to complete a project assigned to OMEGA ELECTRIC will be billed separately. Per the law, by the State of Mississippi, an approved purchase order is required for items over \$1,000.00 and up to \$5,000.00. Any material over \$5,000.00 and up to \$50,000.00 will require a second quote. Any material over \$50,000.00 will require advertisement to receive bids.
