Subject: Authority to purchase ammunition for firing range practice by constables


Dear Board Members:

State law requires prior board approval for expenditures for constables except for those items the county is required by law to furnish. The required items are: (1) two official duty uniforms, (2) a blue light, (3) vehicle identification emblems, and (4) any required training (only once per term).

In addition to the required items, the county has in recent years provided constables with radios, Tasers, flashlights, laptop computers and associated equipment for the E-ticket system. Additionally, the county has paid for any constables who wished to do so to attend the annual Mississippi Constables Association Convention.

Funds were included in this year's budget for ammunition for the constables to use for firing range practice. Constables Brad Harbour has requested that I issue a purchase order for this year's ammunition. This expenditure requires prior board approval.
