EarthCon Consultants, Inc. (EarthCon) is pleased to submit this proposal to provide professional environmental consulting services to the Madison County Board of Supervisors. EarthCon proposes to conduct an Asbestos Material Survey (AMS) of the structure located at 1633 West Pence Street in Canton, Mississippi. As EarthCon understands, the building will require an AMS prior to planned removal activities.

**Scope of Work – Asbestos Material Survey**

EarthCon proposes to perform an AMS of the specified areas of the Madison County Emergency Management Services Complex building at the aforementioned location. The survey will be performed by EarthCon personnel whom are State of Mississippi licensed asbestos inspectors. The inspectors will collect bulk material samples of suspect asbestos-containing materials (ACMs). Bulk samples will be analyzed by an accredited laboratory using the United States Environmental Protection Agency (USEPA) recommended Polarized Light Microscopy (PLM) and Dispersion Staining Method.

The survey results will be presented in a report that will include descriptions of sampled suspect ACMs, confirmed ACM locations, estimated quantities of ACM, and abatement costs, as well as recommendations regarding abatement activities.

### **Cost and Project Scheduling**

EarthCon will perform the above-referenced scope of work on a lump sum (LS) basis. Based on our experience on similar projects, we estimate that the cost to perform the above-referenced scope of work is **\$1,950.00**. EarthCon estimates completion of the project within ten (10) to fifteen (15) days following receipt of notice to proceed.

Additionally, if required, EarthCon can also provide plans and specifications, project management services, and air monitoring services during abatement activities. EarthCon can submit a proposal with an estimated cost for these services, if requested.

### **Terms and Conditions**

EarthCon will invoice the project on a Lump Sum (LS) basis in accordance with the terms and conditions of the Environmental Services Agreement (ESA) executed between EarthCon and Madison County Board of Supervisors on May 24, 2012.
