The Developer Gulf Coast Housing Partnership has informed me of the proposed Sacred Heart Senior Housing development proposed for the site adjacent to Sacred Heart Catholic Church at 1493 Highway 17, Camden, MS, 39045. Based on the information provided to me, the proposed project will be developed on the site directly to the east of the church and will entail 42 units of affordable housing, including 30 one-bedroom and 12 two-bedroom apartments. It is also my understanding that the developer, in partnership with Sacred Heart Catholic Church, is applying for Low Income Housing Tax Credits for the project from the Mississippi Home Corporation.

Although this development is not part of a Madison County concerted community revitalization plan, it is desired within the community where it is located, and it will support the need for affordable housing for low-income households, particularly the elderly. Data gathered by Sacred Heart, through a needs assessment that focused on the area low income senior population, affirms the need and desire in the community for this type of affordable housing development.
