
Memo to Record:

NARRATIVE DATA

On 11/14/17 at approximately 1522 hours I responded to the Madison County Road Department located at 3137 S. Liberty St in Canton, MS for an auto burglary complaint. Upon my arrival I met with the reporting party identified as Johnson, Gregory B (W/M DOB 10/29/73 MSDL 800760946). Johnson stated that on today (11/14) between 1030 and 1100 person(s) unknown removed without permission a Stihl brand chainsaw, model MS 290, S/N 298263541, orange/white in color, from the bed of his Madison County Road Department work truck. The chainsaw had a Madison County Board of Supervisor's (BOS) inventory tag (7151) fixed to the bottom of it. At the time of the incident Johnson and his crew were on Rouser Rd near the BFI land fill. Nothing else appeared to be missing from the truck. There are no known suspect(s) as of this report. The chainsaw was entered into NCIC (NCIC# A874656017)
