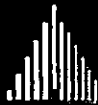

Simply log on at www.appraisalinstitute.org/invoice and select **Manage My Account** in the left column. Under Account options select the **Go Paperless** link.

PAYMENT PLAN DETAILS

A monthly installment plan is available for 2018. Payments are due on the first day of each month starting in January through July.

By electing to participate in the Appraisal Institute payment plan to pay your 2018 annual fee, you authorize the Appraisal Institute to make automatic deductions from your bank account or to charge your credit card the processing fee of \$20 and the amount of fees owed according to the payment plan. You understand that this authorization will remain in effect until you cancel it in writing, and agree to notify the Appraisal Institute in writing of any changes in your account information or termination of this authorization at least fifteen (15) days prior to the next billing date of the payment plan. If the payment plan due dates fall on a weekend or holiday, you understand that the payment may be executed on the next business day. You understand that because this is an electronic transaction, these funds may be withdrawn from your account or charged to your credit card as soon as the payment plan dates. In the case of an ACH Transaction being rejected for Non-Sufficient Funds (NSF) you understand that the Appraisal Institute may at its discretion attempt to process the charge again within thirty (30) days. You acknowledge that the origination of ACH transaction to your account must comply with the provisions of U.S. law. You agree not to dispute this recurring billing with your bank so long as the transaction corresponds to the terms of the Appraisal Institute payment plan and the terms in this authorization.

Candidates, Practicing Affiliates and Affiliates will be considered in default of their payment plan if payment is not made within 30 days of the scheduled payment due dates. If a default on the payment plan occurs, the timetable specified in the Bylaws for late fees, suspension and termination will apply.

LATE FEES

Late fees of 15% of outstanding balances will be assessed after April 1, 2018.
