

PETITION FOR THE ORGANIZATION AND INCORPORATION OF
THE KEARNEY PARK FIRE PROTECTION DISTRICT

TO THE BOARD OF SUPERVISORS OF MADISON COUNTY, MISSISSIPPI:

Pursuant to §19-5-153(1), Mississippi Code Annotated, (1972), petitioners respectfully represent that they are resident citizens and property owners of Madison County, Mississippi, as well as of the proposed district described herein; they are of lawful age; and they desire to organize a fire protection district for the purpose of ensuring the preservation and protection of property from and during fires as may occur in boundaries of the proposed district. Petitioners further represent the following:

1. There is great necessity for the fire protection services to be supplied by the proposed district.
2. The proposed corporation name for the district is Kearney Park Fire Protection District.
3. The property boundaries of the district are as show on the map and description attached hereto, marked as Exhibit "A," and made a part hereof by reference.
4. An estimate of the costs of acquisition or construction of the facilities to be operated by the district, which estimate, however, shall not serve as a limitation upon the financing of improvements or extensions to the facilities, is a sum of \$0.00.
5. The Board of Supervisors is hereby requested to exercise its authority to levy taxes as outlined in §19-5-189, Mississippi Code Annotated, (1972).
6. The Board of Supervisors is hereby requested to exercise its authority to make assessments as outlined in §19-5-191, Mississippi Code Annotated, (1972), for the use and benefit of the proposed district as required by law.

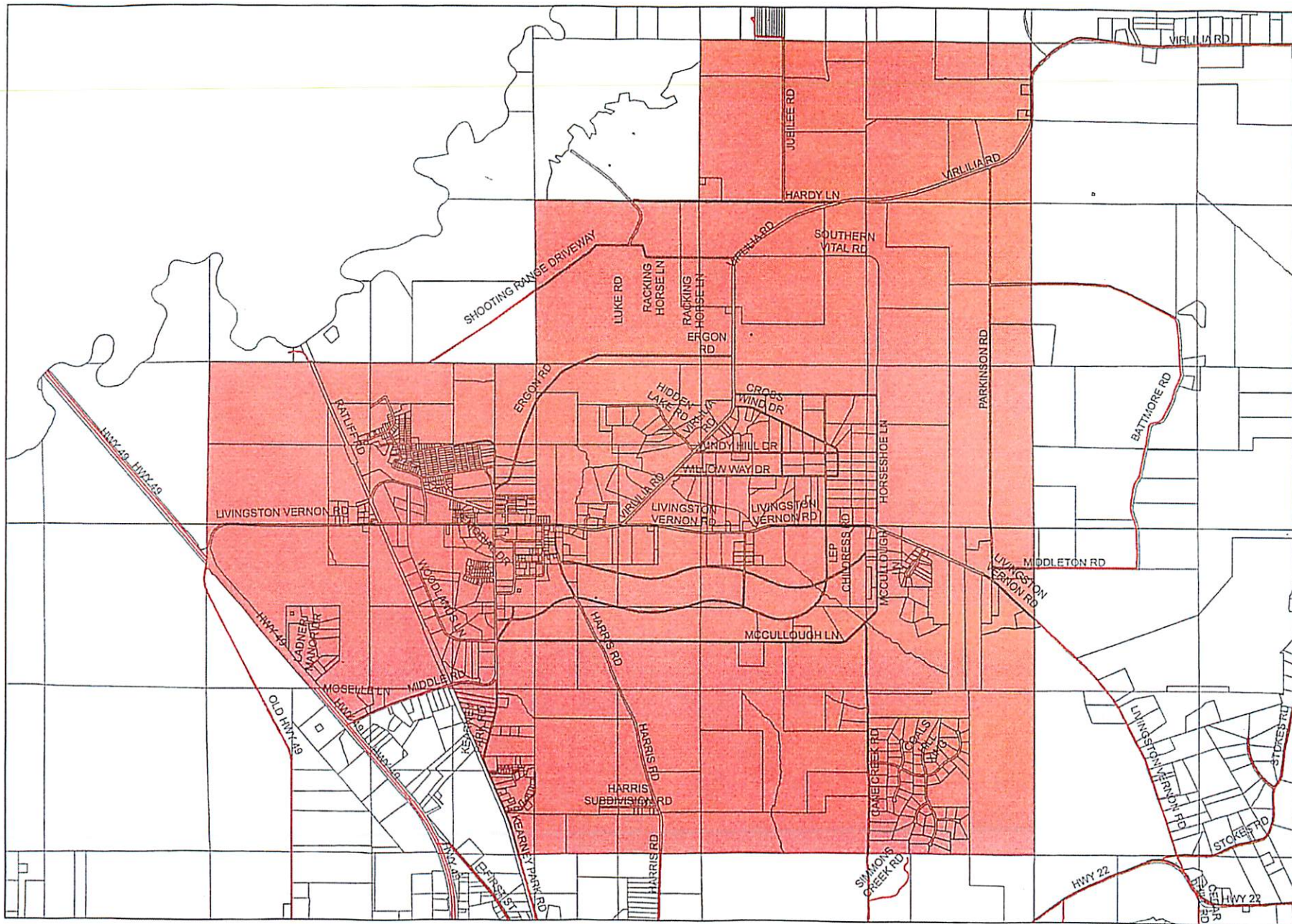
MAP AND LEGAL DESCRIPTION OF PROPOSED BOUNDARIES FOR
KEARNEY PARK FIRE DISTRICT

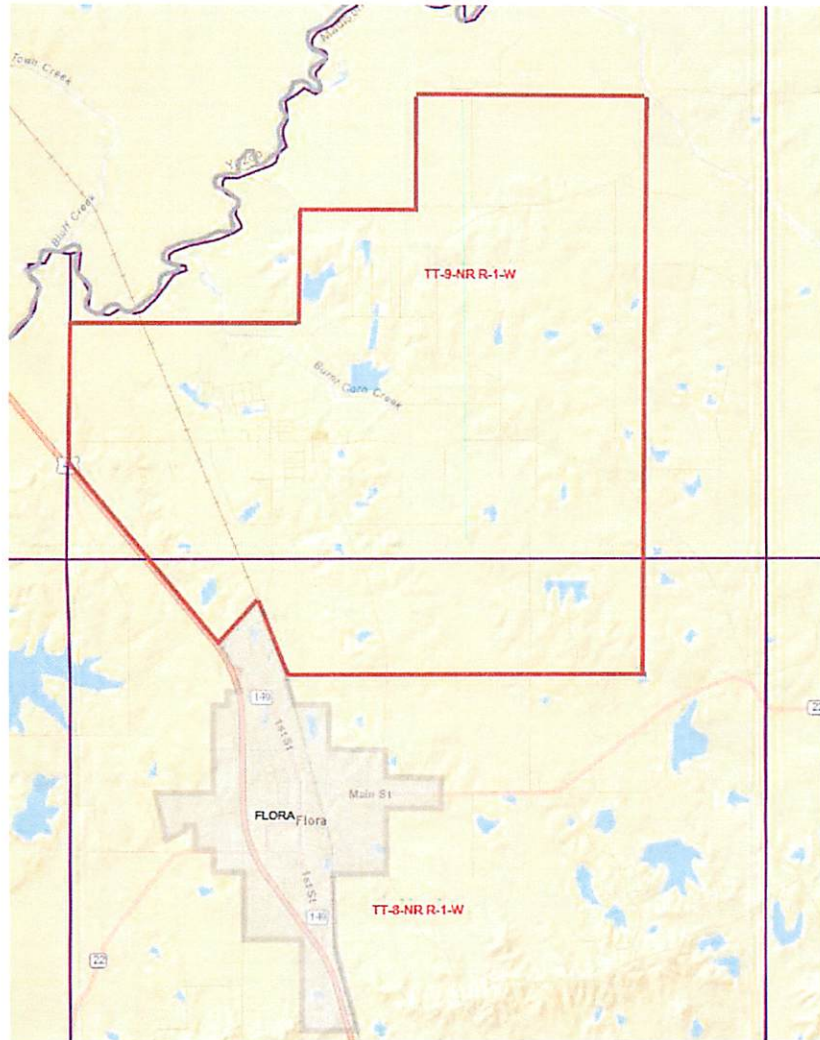

KEARNEY PARK FIRE DISTRICT

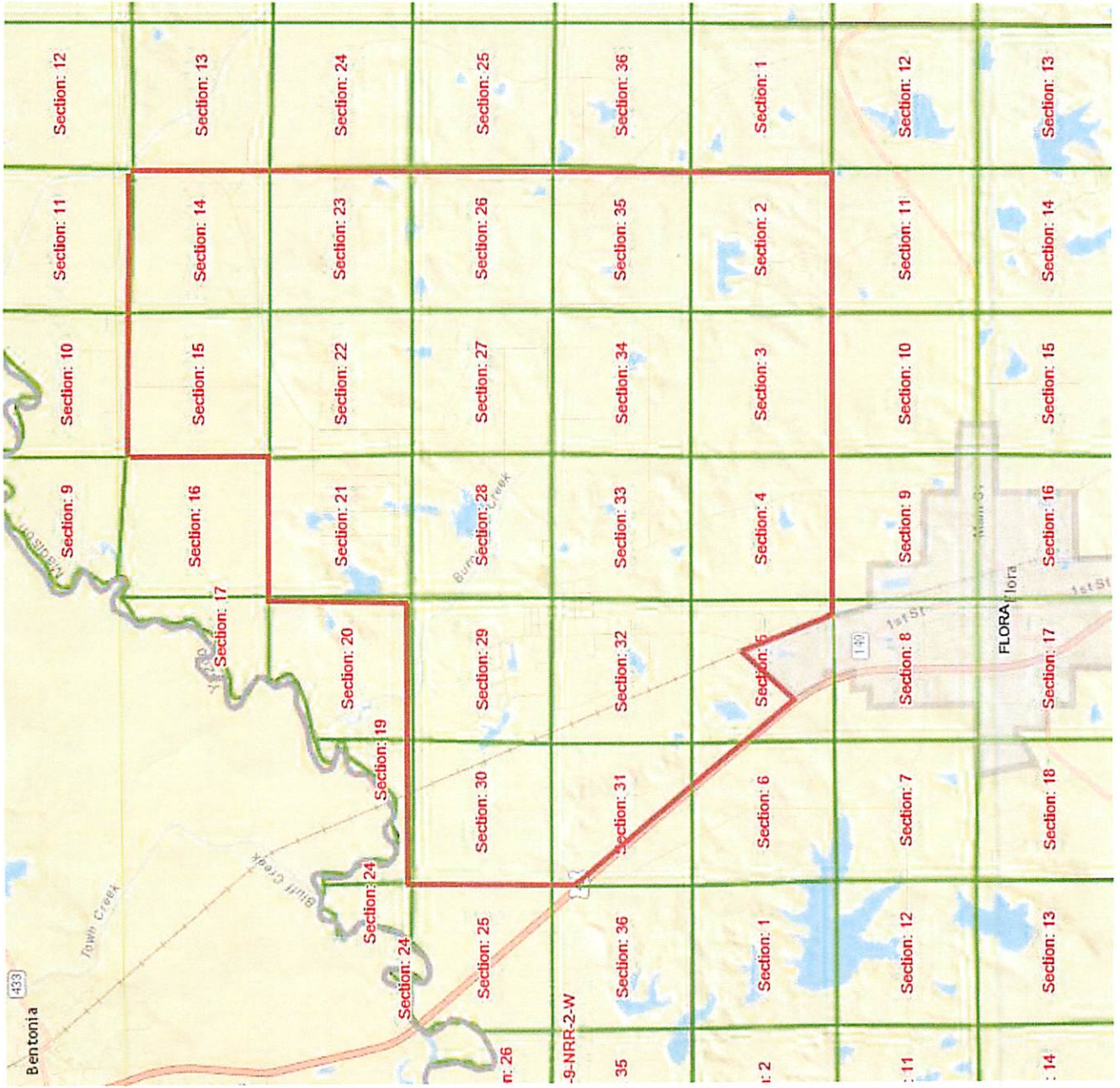

LEGAL DESCRIPTION OF PROPOSED KEARNEY PARK FIRE DISTRICT

Commencing in Township 9N, Range 1W with the Northwest corner of Section 30, proceed East to the Northwest corner of Section 28 in Township 9N, Range 1W, then North to the Northwest corner of Section 21 in Township 9N, Range 1W, then East to the Northwest corner of Section 22 in Township 9N, Range 1W, then North to the Northwest corner of Section 15, then East to the Northeast corner of Section 14, then South, crossing into Township 8N, Range 1W to the Southeast corner of Section 2, then West to the intersection of the south boundary of Section 5 of Township 8N, Range 1W and the east boundary of the Illinois Central Gulf Railroad then continue along the east boundary of the Illinois Central Gulf Railroad northwesterly to the intersection of the north boundary of Middle Road and the east boundary of the Illinois Central Gulf Railroad then continue Southwesterly along the north boundary of Middle Road to the intersection of the north boundary of Middle Road and the west boundary of U.S. Hwy 49 then Northwesterly along the west boundary of U.S. Hwy 49, into Township 9N, Range 1W, to the intersection of the west boundary of U.S. Hwy 49 and west boundary of Section 31 Township 9N, Range 1W then North to the point of beginning at the Northwest corner of Section 30 in Township 9N, Range 1W.
