Subject: Award Weather Warning Sirens Bid

Gentlemen:

Bids were opened April 9 for one or more weather warning sirens. Three bids were received.

After consultation with County Administrator David Overby, EMA Director Butch Hammack, and the State Auditor's office, I recommend that the board take the following action:

- 1. Reject the bid of Federal Signal due to the failure to meet the warranty specifications. The specifications require a minimum one-year on-site labor warranty. Federal's bid only includes on-site labor for the 60 days and does not include travel expense. Additionally, Federal's bid should be rejected due to the fact that its total written bid price for one siren and controller apparatus is erroneously written on the bid sheet \$26,288; however, a check of the arithmetic shows an actual price of \$34,010.
- 2. Award the bid for three weather warning sirens and one CentrAlert computer and set of radio equipment to Precision Communications, Inc. at a total price of \$61,550 (\$17,840 per siren plus \$8,030 for one CentrAlert computer system and radio).
