General Scope of Work:

1. Demolition

- Remove existing cabinets. County to haul off.
- Remove existing carpet, Contractor to haul off.
- Remove existing base, Contractor to haul off.
- Count will remove existing electrical and data connections.

2. Existing furniture

- County to remove and reinstall

3. Cabinet

- Contractor to construct and install new cabinets as shown in drawings to included drawers, cabinets and one lockable drawer per station. (3) Total.
- Contractor to install new Formica on exterior and interior.
- Colors to be chosen by Owner
- Owner will install new electrical and data connections.
- Contractor will cut Formica around new electrical and data connection.
- Contractor to provide new hardware for cabinets and drawers.

4. Paint

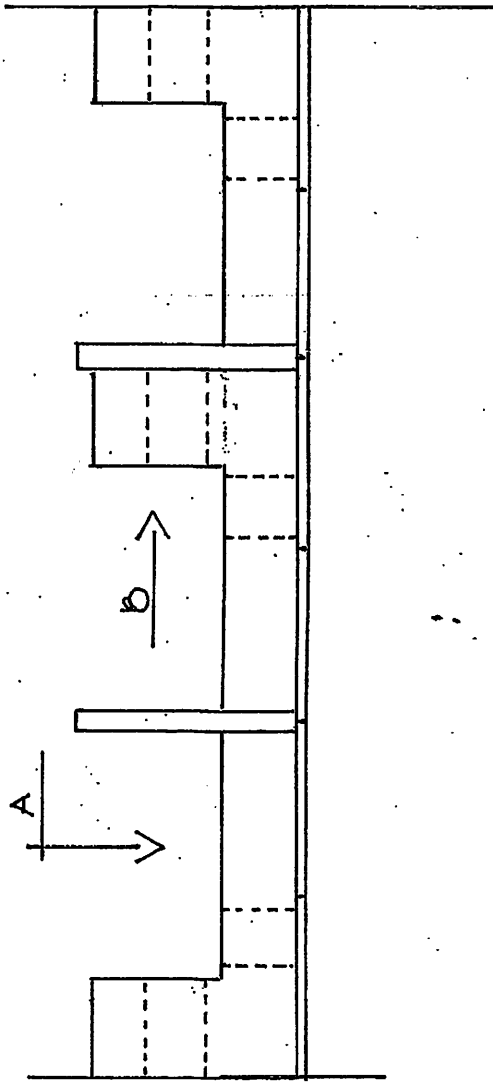
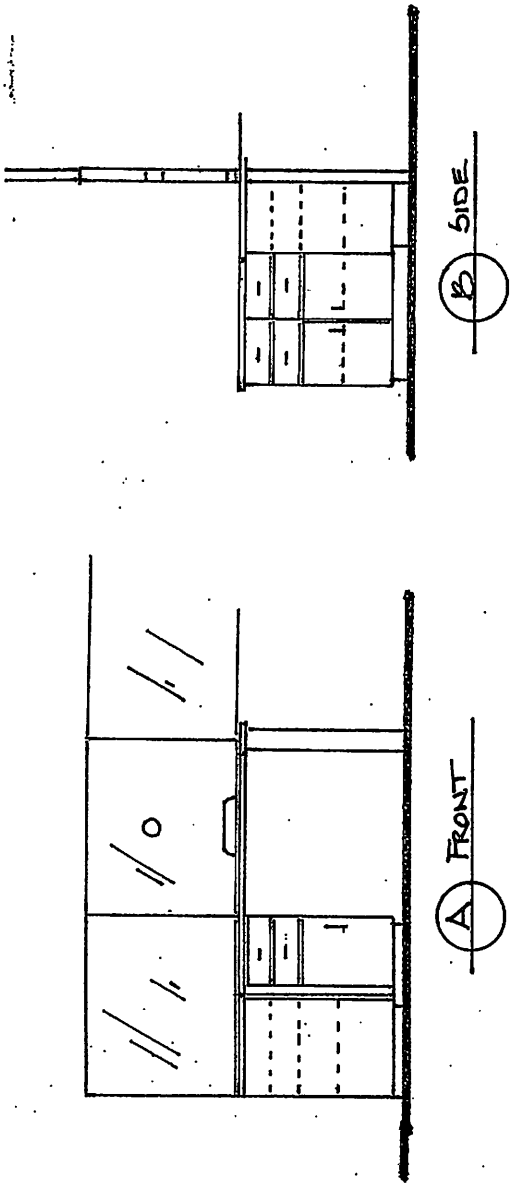
- Colors for wall and trim will be selected by Owner.
- Contractor to paint walls and trim (window and door frame)
- Apply all products in accordance with manufactures instructions.
- Apply each coat to provide uniform appearance.
- Apply a minimum of two coats of paint to provide full coverage.
- Allow all coats to dry prior to applying next coat of paint.

5. Carpet and Base

- Install new carpet and base according to manufactures specifications
- Color to be chose by Owner

6. Clean Up

- Collect and dispose all waste material, trash and debris as a result of this project on a daily basis.


