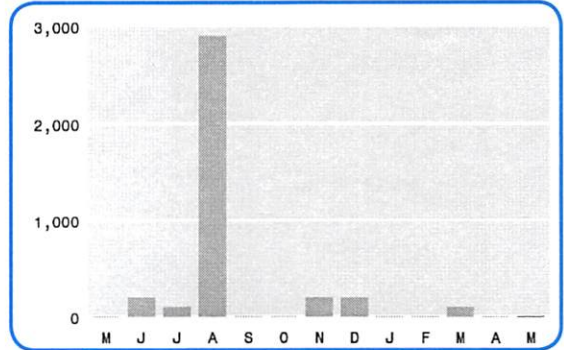

Prior balance and **reconnect** fees must be paid in full before service will be restored.


The nominating committee of the Board of Directors has nominated for re-election the following:
