

- C. The Guest of the Tax Assessor and/or Collector is typically a spouse or a significant other.
- D. If the Tax Assessor and/or Collector <u>IS NOT</u> bringing a spouse or significant other, a Deputy may be the Guest.
- E. If the Tax Assessor and/or Collector <u>IS</u> bringing a spouse or significant other, a Deputy must register and pay the deputy conference fee (\$150.00)
- F. NO SPLITTINGII If the spouse or significant other attends any portion of the conference, then the Deputy must pay the deputy conference fee of \$150.00.
- G. The Deputy/registration fee is \$150.00 \$
 - H. The guest registration fee is \$150.00
 - I. The retired Assessor/Collector fee is \$150.00
 - J. There is a separate special registration fee scale for children at conference.
 - a. Youth ages 0-6 there is no fee.
 - b. Youth ages 6-13 the fee is \$75.
 - c. Youth ages 14 and up will be required to register as a regular guest for a fee of \$150.
