**ORDER AUTHORIZING PAYMENT OF
FEES AND EXPENSES**

THIS CAUSE, having come on this day for hearing on the motion *ore temus* of Ronny Lott, Clerk of this Honorable Court and Chancery Clerk of Madison County, Mississippi, requesting the payment of certain fees and expenses of office for the month of **June 2018**, and the Court, having duly considered the same and being aware that said clerk has performed numerous and varied services on behalf of this Court and the citizens of this county, finds that said motion is well taken and should be granted.

IT IS, THEREFORE, ORDERED that the following items of fees and expenses be and the same are hereby approved for the **June 2018** term of Chancery Court held in the City of Canton, Mississippi and are hereby authorized to be paid unto Ronny Lott, Chancery Clerk of Madison County, Mississippi, to-wit:

(1) For Attendance Upon the Chancery Court:

(a) For each day, first Chancellor sitting: \$50.00 per day each for himself and two deputies *Judge Brewer*: June 1, 4, 5, 6, 11, 12, 13, 15, 18, 19, 20, 22, 25, 26, 27, and 29; *Judge Walker*: June 14, 21, and 28)
19 days at \$150.00 per day (§ 25-7-9(h)) (Fund # 001-160-454) \$2,850.00

(b) For each day, second Chancellor sitting: \$50.00 per day, Clerk only: (*Judge Clark*: June 5, 13, 15, and 20; *Judge Walker*: June 1, 4, 6, 7, 11, 12, 18, 19, 22, 25, 26, and 29)
16 days at \$50.00 per day (§ 25-7-9(h)) (Fund # 001-160-454) \$800.00

(c) No more than five (5) extra days per term for the Clerk and two deputies for attendance upon the Court to get up records: \$50.00 per day for himself and two deputies:
5 days at \$ 150.00 per day (§ 25-7-9(i)) (Fund # 001-160-454) \$750.00

(2) For administrative services performed in connection with commitment proceedings listed below such as consultations with family or friends, scheduling physicians, providing insurance information to hospitals, and making arrangements for pre-screenings and follow-ups: \$60.00 each:

One (1) mental health commitment at \$60.00 each

Zero (0) alcohol and drug commitments at \$60.00 each

(3) For pauper's oaths in connection with commitment proceedings denoted with a "†" above:


(4) For pauper's oaths filed in proceedings other than commitments:


(5) For public services not otherwise specifically provided for, contingent upon the approval of the Madison County Board of Supervisors, an annual sum not to exceed \$5,000.00 payable \$416.67 per month (§ 25-7-9(j))(Fund # 001-101-453) \$416.67
