


I am writing with regard to the position of Madison County Juvenile Drug Treatment Court part-time parent liaison, Jessica C. Culpepper. While this is a request for salary increase, you will see from the information below that the salary increase would not come from County funds.

The Juvenile Drug Treatment Court is funded by the Administrative Office of Courts ("AOC") and by the JAG grant via the Mississippi Department of Public Safety. (The AOC pays for Juvenile Drug Treatment Court salaries, benefits, treatment, drug testing and supplies, laboratory expenses, staff office expenses, training and travel and other needed expenses. The JAG grant funds only salaries and benefits).

Jessica Culpepper has severed as the parent liaison since February 2017. This will be the first time her salary has been adjusted. Mrs. Culpepper has done exemplary work setting up parent support meetings and serving as an outlet for the parents of the young people of Madison County. I would like for her salary to increase from \$8,550 to \$11,500. AOC has the funds to cover this increase due to increase funding and receiving the JAG funds to cover the salaries of the remainder of our staff. I would like this to go into effect August 1, 2018.
